ORDINANCE NO. 9之

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS OF THE CITY OF WATERTOWN, MINNESOTA

THE CITY COUNCIL OF THE CITY OF WATERTOWN, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. That pursuant to Minnesota Statutes, Section 414.033, the City Council of the City of Watertown, having prior hereto on November 3, 1976, accepted a Petition for Annexation into the corporate limits of the City of Watertown by all of the property owners of those certain lands as hereinafter set forth and copies of said Petition having been filed with the Minnesota Municipal Board, the Board of Supervisors of the Town of Watertown, the Carver County Board of Commissioners, and the Secretary of State of the State of Minnesota, on November 23, 1976, as required by law and rules of the Minnesota Municipal Board, and more than sixty (60) days having elapsed since such filing and no written objections having been made, or otherwise, and the Council having determined that said lands abut the present corporate limits of the City of Watertown and do not exceed 200 acres and are conditioned as properly to be subjected to municipal government and that annexation of said lands would be to the best interests of the City of Watertown and the lands to be annexed, the corporate limits of the City of Watertown are declared hereby extended to encompass and include all that certain land described as follows, to-wit:

Tract 1 - (Charles P. and Teresa M. Salden)

The North Half of the South 2 acres of the East 13.8 acres of the North Half of the Southwest Quarter of Section 9, Township 117, Range 25.

Tract 2 - (Lavin M. and Lorena E. Schmidt)

The South 150 feet of the following described tract of land: The East 13.8 acres of the North Half of the Southwest Quarter of Section 9, Township 117, Range 25, except the South 2 acres.

Tract 3 - (Duane A. and Mary C. Schumacher)

The North 150 feet of the South 300 feet of the following described tract: The East 13.8 acres of the North Half of the Southwest Quarter of Section 9, Township 117, Range 25, except the South 2 acres.

Section 2. The City Clerk is hereby directed to file certified copies with the Minnesota Municipal Board, the Town Clerk of the Town of Watertown, the Carver

County Auditor, and the Minnesota Secretary of State and to publish this Ordinance in the <u>Carver County News</u>, all as required by law.
