ORDINANCE NO. 290
An Ordinance Extending the Corporate Limits
of the City of Staples and Incorporating
Additional Territory Therein
John G. Wilson
Secretary of State

The City Council of the City of Staples does ordain as follows:

Section 1. A petition has been filed with the governing body of the City of Staples, Minnesota by Dale E. Petersen, the owner of the following described real estate for the purpose of having said real estate included within the corporate limits of the City of Staples, Minnesota:

Lots 1 and 2, Block 2, 1st Addition to Pine Crest, according to the plat thereof on file and of record in the Office of the Wadena County Recorder, together with all abutting streets and roadways.

Section 2. The above described property is platted and Dale E. Petersen is the sole owner of the property.

Section 3. The Petition for Annexation has been filed with the Town Board of Thomastown Township, the Wadena County Board of Commissioners, the Minnesota Municipal Commission, and the City of Staples more than 60 days prior to the first reading of this ordinance and no objection to the petition has been received.

Section 4. All fees required to be paid by the petitioners have been duly paid.

Section 5. The City Council hereby determines that the annexation will be in the best interests of the City of Staples, Minnesota, and of the territory affected; the territory described herein abuts upon the City and is so conditioned as to be properly subjected to City government.

Section 6. Therefore, the City of Staples, Minnesota, hereby ordains and declares that the property hereinabove described be and the same are hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.

Section 7. This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the Town Clerk of Thomastown Township, The Wadena County Auditor, and the Minnesota Secretary of State.
