## ORDINANCE NO. 174

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF CAMBRIDGE, ISANTI COUNTY, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA

WHEREAS, a certain petition dated August 8, 1974, requesting annexation of the territory described below, was duly presented to the council and filed in the office of the City Clerk on August 12, 1974; and

WHEREAS, said petition for annexation was duly signed by all of the owners of the property described below; and

WHEREAS, the City Council of Cambridge did adopt a Resolution approving the proposed annexation on August 12, 1974; and

WHEREAS, a true and correct copy of said Petition for Annexation together with the Resolution approving the proposed annexation was filed in the office of the Township Clerk of the Township of Cambridge on January 2, 1975, in the office of the County Auditor in and for Isanti County, Minnesota, on January 2, 1975 (the said Township and County being the same in which all of the lands to be annexed is located); and with the Minnesota Municipal Commission on January 2, 1975; and

WHEREAS, more than sixty (60) days have elapsed since said petition and resolution has been filed with the said Cambridge Township, Auditor of Isanti County, and Minnesota Municipal Commission, and no written objections to the annexation from any municipal subdivision or person has been filed or submitted to the City of Cambridge or the Minnesota Municipal Commission; and

WHEREAS, the City Council has determined that the annexation of the territory hereinafter described will be to the best interest of the City of Cambridge and of the territory affected and that said territory is so conditioned as properly to be subjected to city government:

NOW THEREFORE, THE CITY COUNCIL OF CAMBRIDGE ORDAINS:

Section 1. Declarations. It is hereby determined that the territory described below abuts upon the City of Cambridge and is so conditioned as to properly be subjected to city government, and that the annexation thereof would be to the best interest of the City of Cambridge and the territory affected.

Section 2. Territory Annexed. The corporate limits of the City of Cambridge are hereby extended to include the territory described as follows, to-wit:

That part of Government Lots 3 and 4, Section 29, Township 36, Range 23, and Lot 82, Auditor's Subdivision No. 8 of the Village of Cambridge, all in Isanti County, Minnesota, described as follows: Beginning at a point on the extension West of the centerline of Fifth Avenue N.W., distant 33.0 feet West of the West line of Rippey's Addition, Cambridge, Minnesota; thence West along the extension of said centerline a distance of 1,308.0 feet; thence Southwesterly at a deflection angle to the left of 50 degrees a distance of 255.3 feet; thence West at a deflection angle to the right of 50 degrees to the thread of the Rum River; thence Northeasterly along the thread of said Rum River to its intersection with a line described as Commencing at a point on a line 33.0 feet West of follows: and parallel to the West line of said Rippey's Addition, distant 451.9 feet North of the extension West of the centerline of said Fifth Avenue N.W.; thence West and parallel to the extension of said centerline a distance of 885.79 feet; thence Northeasterly at a deflection angle to the right of 94 degrees to the thread of the Rum River; thence Southwesterly and East along last described lines to a point in a line 33.0 feet West of and parallel to the West line of Rippey's Addition

distant 451.9 feet North of the extension West of the centerline of Fifth Avenue N.W.; thence South along said parallel line 451.9 feet to the point of beginning, except a strip of land 33.0 feet in width lying North of and adjacent to Fifth Avenue N.W. as the ,same is dedicated in the recorded plat of Sunset Knoll, Isanti County, Minnesota, also except the recorded plat of River Heights on file at the Register of Deeds Office, Isanti County, Minnesota.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance is the Office of the Secretary of the State of Minnesota, in the office of the Minnesota Municipal Commission, in the office of the Isanti County Auditor, and with the Cambridge Town Clerk, all pursuant to Minnesota Statutes 414.033 Subdivision 7.

Section 4. Effective Date of Annexation. Annexation shall be complete from and after the date when certified copies of this Ordinance have been filed as directed in Section 3, hereof.
