ORDINANCE NO. 1765

AN ORDINANCE Annexing to the City of Rochester, Minnesota Certain Unplatted Land in Cascade Township, Sections 14 and 23, Township 107 North Range 14 West, Olmsted County, Minnesota.

The Common Council of the City of Rochester do ordain:

Section 1. The following described unplatted land in Cascade Township, Olmsted County, Minnesota, is owned and abuts the municipal limits of the City of Rochester:

Parcel A: All that part of the Northwest quarter of the Northeast quarter of Section 23, Township North 107, Range 14 West, less the following described property: Commencing for a place of beginning at a point 42 rods north of the Southeast corner of said Northwest quarter of the Northeast quarter, thence parallel with the south line thereof about 20 rods to the Zumbro River, thence northerly along the river 3 rods, thence easterly to a point on the east line thereof 7 rods, north of the place of beginning, thence south to the place of beginning.

Parcel B: All that part of the South half of the Southwest quarter of the Southeast quarter, of Section 14, Township 107 North, Range 14 West, lying south and west of the Zumbro River.

Parcel C: All that part of the East half of the Southwest quarter and the Southeast quarter of the Northwest quarter, Section 14, Township 107 North, Range 14 West, which lies east of the center line of the Township road running in a northerly and southerly direction through said land.

Parcel D: All that part of the Northeast quarter of the Northwest quarter of Section 23, Township 107 North, Range 14 West.

Section 2. The land described in Section 1 above comprising of approximately 163.0 acres is hereby annexed, added to and made a part of the City of Rochester, Minnesota, as effectually as if it had originally been a part thereof.

Section 3. This ordinance shall take effect and be enforced from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the Cascade Town Clerk, the County Auditor, and the Secretary of State.




