

CRDIWANCE NATION ANEXING TO THE GITY OF ROCHES TER, MINNESOTA, CERTAIN UNPLATTED LAND NOT EX-CEEDING 200 ACRES IN AREA IN SECTION 23, TOWNSHIP 107 NORTH, RANGE 14 WEST, OLMSTED COUNTY, MINNES SOTA, AND ESTABLISHING THE ZONING THEREFOR. THE COMMON COUNCIL OF THE CITY OF ROCHESTER DD OR-DAIN: Section 1.
