AN ORDINANCE TO ANNEX TO THE CITY OF MEDFORD, THE FOLLOWING UNINCORPORATED LAND ADJUTING THE CITY OF MEDFORD, COUNTY OF STEELE, STATE OF MINNESOTA, AND DESCRIBED AS FOLLOWS, TO-WIT:

Lot 8 in Section 8, Township 108 North of Range 20 West, EXCEPTING THEREFROM the following two parcels:

- 1) Commencing at the West end of Wilton Street of Medford Village and the North side of said road, thence West for 13 feet, thence North 4 degrees 06 minutes West for 216.2 feet, to the south bank of the river, thence Easterly along said bank to the 1/8 line, thence South 1 degree 35 minutes East for 264 feet to the point of beginning.
