## ORDINANCE NO. 77-2

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF FARIBAULT, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated November 22, 1976, requesting annexation of territory described hereinafter was duly presented to the council of the City of Faribault, Minnesota, at a regular meeting thereof held on the 25th day of January, 1977, at 7:30 P.M., and was duly considered by that body; and

WHEREAS, the quantity of land embraced within the area described in said petition and bounded as described therein is approximately 8.9 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all owners of such land; and I

WHEREAS, no objections to such annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the town board of Wells Township, Rice County, Minnesota and the Board of County Commissioners of Rice County, Minnesota, have executed waivers of objections to the proposed annexation of land; and

WHEREAS, the land described in such petition abuts upon the city limits of the City of Faribault, Minnesota at the westerly boundary thereof; and

WHEREAS, such annexation will be to the best interests of the municipality and territory affected,

## THE CITY OF FARIBAULT ORDAINS:

Section 1. DETERMINATION. The city council hereby determines (1) the annexation will be to the best interests of the city and of the territory affected; (2) the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) none of said territory is now included within the limits of any city, village, or borough.

Section 2. TERRITORY ANNEXED. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city of Faribault, Minnesota as effectually as if it ha originally been a part thereof:

Minnesota State Trunk Highway #60 beginning at its western terminus within the city of Faribault and continuing from thence westerly to the west line of the East One-half (E 1/2) of Section 35, Township 110 North, Range 21 West of the Fifth Principle Meridian, Rice County, Minnesota, AND

Part of the Southwest Quarter of the Northeast Quarter of Section 35, Township 110 North, Range 21 West of the Fifth Principal Meridian, Rice County, Minnesota, described as follows: Beginning at the Southwest corner of said Southwest Quarter of Northeast Quarter; thence northerly, along the West line of said Southwest Quarter of Northeast Quarter (for purposes of this description bearing of said West line is assumed North 0°29'40" West), a distance of 6.55 feet to a point in the northwesterly right of way line of Minnesota Trunk Highway 60; thence North 60°07'46" East, along said Highway right of way line, 391.45 feet to the true point of beginning of the parcel to be herein described; thence continue North 60°07'46" East, along said Highway right of way line, 531.79 feet to the westerly right of way line of Interstate Highway 35; thence North 2°12'28" West, along said westerly right of way line of Highway 35, a distance of 562.71 feet; thence continue along said westerly right of way line, North 6°19'23" East, about 56 feet to the water's edge of Cannon River; thence westerly, along said water's edge of Cannon River to a point in a line North 2°12'28" West from said true point of beginning; thence South 2°12'28" East, about 949 feet to said true point of beginning; to-gether with a strip of land, 33.00 feet in width lying westerly from and adjacent to the westerly line of said above described parcel, and lying between said northerly right of way line of Highway 60 and said Cannon River; subject to an easement for driveway purposes over and across a strip of land 33.00 feet in width described as follows: commencing at the true point of beginning of the herein described parcel; thence North 60°07'46" East, along said northwesterly right of way line of Highway 60, a distance of 37.00 feet; thence North 29°52'14" West, 33.00 feet; thence South 60°07'46" West, 19.70 feet; thence South 2°12'28" East, 37.26 feet to said true point of beginning; containing 8.9 acres, more or less.

Section 3. FILING. The city administrator is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Rice County Auditor, and the Town Clerk of Wells Township.

Section 4.. EFFECTIVE DATE OF ANNEXATION. This ordinance shall take effect and be in force 30 days from and after its passage and publication and the filing of certified copies as directed in Section 3.
