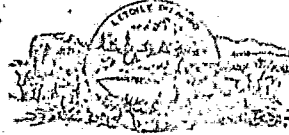



ORDINANCE 173

The City of Le Center does hereby Ordain as follows:

I.

That proceedings for annexation relative to the property hereinafter described has been initiated pursuant to the provisions of M.S.A. 414.033 and that all of the provisions of said Statute have been complied with.

II.

That said land is unplatted and the annexation thereof would be to the best interest of the municipality and of the territory affected thereby.

III.

Pursuant thereto the following described property, to-wit:

Beginning at a point 75.00 feet North and 660.00 feet West of the South one quarter corner of Section Number 29, Township Number 111 North, Range Number 24 West, Le Sueur County, Minnesota, thence North 189.00 feet, thence East 165 feet, thence South 189 feet, thence West 165.00 feet to place of beginning, being 0.71 acres of the Southeast One Quarter of the Southwest One Quarter of said Section Number 29, Le Sueur County, Minnesota.
