## PRINTER'S AFFIDAVIT OF PUBLICATION

AN ORDINANCE EXTENDING AND INCREASING THE CORPORATE LIMITS OF THE CITY OF SABIN, COUNTY OF CLAY, STATE OF MINNESOTA, PURSUANT TO THE PROVISIONS OF MINNESOTA STATUTES 414.033, BY ANNEXING THERETO CERTAIN TRACTS OF LAND CONTIGUOUS TO AND NOT EMBRACED WITHIN THE PRESENT

LIMITS OF THE CITY OF SABIN. PREAMBLE

Since two petitions in writing have een presented to the City Council of the Bity of Sabin signed by owners of certain eal and personal property requesting innexation of their properties to the City

The City Council of the City of Sabin loes ordain as follows:
SECTION ONE

The City Council hereby determines that the two petitions were signed by all of the owners of the real property, i as shown by the last assessment of such property and as would be subject to taxation by the City of Sabin in the event of annexation, within the tracts described as follows:

Outlot G and the NE¼ of Section 7, Township 138 North, Range 47 West, which lies East of the East right of way line of the Great Northern Railroad, Clay County; Minnesota; all containing 76.9 acres, more or less;

Beginning at a point on the South line. of Section 7, Township 138 North, Range 47 West of the Fifth Principal Meridian said Point of Beginning being located 747.00 feet East of the South one-quarter corner in said Section 7; thence South 89 degrees 59' 58" East along the aforementioned South line of Section 7 a distance of 377.15 feet; thence North 01 degrees 24' 17" East a distance of 1,555.00 · feet; thence North 89 degrees 59' 38" West a distance of 1,155.10 feet, moreor less, to the point of Beginning; said tract containing 9.965 acres,

more or less; and that such tracts are contiguous to the City of Sabin and not embraced within the city limits; they are unplatted, do not exceed 200 acres in area, and are within the areas described in the two petitions; the two petitions were filed with the Minnesota Municipal Board, the Elmwood Township Board, the Clay County Board of Commissioners, and the Clay County Zoning Office and no objections to said petitions were filed within sixty days after said filings; and it is in the best. interests of the City of Sabin and the tracts described in Section One that those tracts be annexed to the City of Sabin; therefore the City Council of the City of Sabin has jurisdiction to annex the above-described tracts to the City of

### SECTION TWO

The corporate limits of the City of Sabin are hereby extended and increased so as to include and embrace within the corporate limits of the City of Sabin the tracts described in Section One-hereof, and such tracts are hereby annexed and declared to be a part of the City of Sabin. SECTION THREE

This ordinance shall be filed with the Minnesota Municipal Board, the Elmwood Township Board Clerk, the Clay County Auditor and the Minnesota Secretary of State and posted in two conspicuous public places in the City of Attest: Sabin and published once in the official newspaper.

(6) Said newspaper files a copy of each issue immediately with the State Historical Society. (7) Said newspaper has complied with all the foregoing conditions for at least two years preceding the day or dates of publication mentioned below. (8) Said newspaper has filed with the Secretary of State of Minnesota on May 20, 1965 and each January 1 thereafter an affidavit in the form prescribed by the Secretary of State and signed by the managing officer of said newspaper and sworn to before a notary public stating that the newspaper is a legal newspaper.
