Corner of Lot 1 of said Section, thence South 52° 44' West 529.23 feet to point on Island, thence S. 30° 12' W. 121 ft., thence S. 50° 23' W. 126 ft., thence S. 75° 27' W. 133.30 ft., thence S. 45° 31' W. 126.40 ft., thence N. 23° 58' W. 115.30 ft., thence N. 9° 36' E. 87.30 ft., thence N. 25° 18' E. 189.60 ft., thence N. 57° 11' E. 97.90 ft., thence S. 75° 53' E. 195.50 ft., thence S. 42° 55' E. 76.20 ft., to Hub No. 1 and point of beginning, containing 2.15 acres.
