

Thence West along the South line of said Township Road a distance of 205.5 feet;

Thence South 212 feet, more or less, to the South line of that certain tract of land conveyed by J.H. Thoreson and Nora S. Thoreson to Clifford I. Thoen by Warranty Deed recorded in Book 34 of Deeds, Page 498 in the Office of the Pope County Recorder;

Thence East along the South line of said tract of land a distance of 205.5 feet to the East line of said Lot Three (3);

Thence North along the East line of said Lot Three (3) to the place of beginning.

TRACT VI:

Lot Five (5), County Subdivision of the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$), Section Eighteen (18), Township One Hundred Twenty-five (125), Range Thirty-seven (37).

Section 3. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Clerk of Glenwood Township, and the County Auditor.

Section 4. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 3 hereof.

Section 2. The corporate limits of the City of Glenwood are hereby extended to include the platted land described as follows, and the same is hereby annexed to and included within the City of Glenwood as effectually as if it had originally been a part thereof:

TRACT I:

All that part of the plat of the Glenwood Cemetery, according to the plat thereof recorded in Book B of Plats, Page 42 in the office of the Pope County Recorder, which lies South of the South line of Government Lot Two (2), Section Eighteen (18), Township One Hundred Twenty-five (125), Range Thirty-seven (37).

TRACT II:

All that part of the plat of Lakeview Addition to the Glenwood Cemetery, according to the plat thereof recorded in Book C of Plats, Page 14 in the office of the Pope County Recorder, which lies South of the South line of Government Lot Two (2), Section Eighteen (18), Township One Hundred Twenty-five (125), Range Thirty-seven (37).

TRACT III:

Lot Four (4), County Subdivision of the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$), Section Eighteen (18), Township One Hundred Twenty-five (125), Range Thirty-seven (37).

TRACT IV:

Lot Nine (9), County Subdivision of the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$), Section Eighteen (18), Township One Hundred Twenty-five (125), Range Thirty-seven (37).

TRACT V:

That part of Lot Three (3), County Subdivision of the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$), Section Eighteen (18), Township One Hundred Twenty-five (125), Range Thirty-seven (37), described as follows:

Commencing at the Southeast corner of said Lot Three (3); thence North a distance of 424 feet, more or less, to the South line of the adjacent Township Road, which is the place of beginning;

Ordinance No. 182

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GLENWOOD TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain Petition dated November 2, 1976, requesting annexation of the territory hereinafter described was duly presented to the City Commission of the City of Glenwood on the 2nd day of November, 1976;

AND WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is 10.6 acres of platted land, no part of which is included within the incorporated limits of a City or borough;

AND WHEREAS, the Petition was signed by all owners of the lands described therein;

AND WHEREAS, no objections to the annexation have been received from the Town Board of Glenwood Township, or from the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed;

AND WHEREAS, the land described in the Petition abuts upon the City limits of the City of Glenwood at the northerly boundary thereof;

NOW, THEREFORE, THE CITY OF GLENWOOD DOES ORDAIN:

Section 1. The City Commission hereby determines that the annexation will be to the best interests of the City and of the territory affected; that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and that none of said territory is now included within the limits of any City or borough.
