ORDINANCE NO. 204

AN ORDINANCE DECLARING CERTAIN LAND
TO BE ANNEXED TO THE CITY OF
ST. CLAIR, MINNESOTA

The Common Council of the City of St. Clair, Minnesota,
does ordain as follows:

1. That the following described tract of land is sixty percent (60%) surrounded on three sides by the municipal boundaries of the City of St. Clair and notice of intention to annex said land has been duly served as required by statute:

Commencing at the intersection of the east line of the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 8, Township 107 North, Range 25 West with the south right-of-way line of State Highway No. 83; thence north along said east line to the south right-of-way line of the Chicago/Milwaukee Railroad right of way; thence north 56 degrees 03 minutes west along the said south railroad right-of-way line 912.59 feet; thence south 42 degrees 13 minutes 37 seconds west 454.70 feet to the south right-of-way line of State Highway No. 83; thence southeasterly along said south right-of-way line to the place of beginning. Said tract contains 13.75 acres more or less. And, any and all public or railroad rights of way within or adjacent to said tract.

2. The above described land is hereby declared annexed to and made a part of the City of St. Clair, Blue Earth County, Minnesota, in accordance with Minnesota Statute 414.033, Subd. 3.

3. This Ordinance shall take effect from and after its date of passage and publication.
