ORDINANCE 174

The City of Le Center does hereby Ordain as follows:

Section I: That proceeding for annexation relative to the property hereinafter described has been initiated pursuant to the provisions of M.S.A. 414.033 and that all of the provisions of said Statute have been complied with.

Section II: That said land is unplatted and annexation thereof would be to the best interest of the municipality and the territory affected thereby.

Section III: Pursuant therto the following described property, to-wit:

The West 693.00 feet of the North 264.00 feet of the Northeast Quarter (NE $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$), Section Number 29, Township 111N, Range 24 West, Le Sueur County, Minnesota.

is hereby annexed to and made a part of the City of Le Center, Le Sueur County, Minnesota.

Section IV: A copy of this Ordinance shall be filed with the Minnesota Municipal Commission, Town Clerk of Lexington Township, County Auditor, Le Sueur County, Minnesota, and the Secretary of State, State of Minnesota.

Section V: This Ordinance shall become effective from and after its passage and publication and upon compliance with the provisions of the preceeding section relative to filing copies with the proper officials in the various municipal corporations involved.
