## ORDINANCE #6.64

AN ORDINANCE AMENDING ANNEXING CERTAIN PARCELS OF LAND TO THE CITY OF INTERNATIONAL FALLS AND PLACING THE SAME WITHIN THE JURISDICTION OF SAID CITY.

The City Council of the City of International Falls do ordain as follows:

Section I. That the following parcels of land are completely Surrounded by the City of International Falls.

Section II. That after due consideration, the City Council has deemed it to be in the best interest of the City that said land be annexed to and become a part of said City, said property being described as follows:

That parcel of land contained within Government Lot Three (3) and Four (4) of Section Four, Township Seventy (70), Range Twenty-four (24), and in Government Lot Four (4) and Southeast Quarter (SE1/4) of the Southwest Quarter (SW1/4), of Section Thirty-three (33), Township Seventy-one (71), Range Twenty-four (24), described as follows:

Beginning at a point 416.57' East (E) of the Southwest corner of Gov't Lot 4, Section 34, said point being on the Southeast (SE) right-of-way line of State Trunk Highway 11-71; thence Northeasterly along said right-of-way line to an intersection with the South (S) line of 11th Street; thence West (W) across said highway on the extended South (S) right-of-way line of 11th Street to a point of intersection on the Northwest (NW) right-of-way line of State Trunk Highway 11-71; thence Southwest (SW) along said highway right-of-way line to the Southeast (SE) corner of Falls Nursing Home property; thence Westerly along the South (S) boundary of the Nursing Home property to a point of intersection on the East (E) boundary of the City Waste Treatment Plant property; thence 175' South (S) along said boundary to the intersection with the North (N) boundary of the Border Patrol site; thence West (W) along the North (N) boundary of the Border Patrolsite, the same being the South (S) boundary of Waste Treatment Plant, 84' to a cement monument on the Northwest (NW) corner of the Border Patrol site; thence, along the West (W) boundary of the Border Patrol site; thence along the South (S) boundary of said site, 154' to the concrete monument at the South west (SW) corner of said site; thence Southwest (SW) along the Southeast (SE) corner of said site; thence Southwest (SW) along the Southeast (SE) corner of said site; thence Southwest (SW) along said line to f-way 50' Southeast (SE) to the intersection with the Northwest (NW) right-of-way line of said highway; thence Southwest (SW) along said line to a point perpendicular to right-of-way from point of beginning; thence Southeast (SE) along said line to point of beginning; thence

And that part of Government Lot Two (2), Section Thirty-three (33), Town-ship Seventy-one, Range Twenty-four (24) described as follows:

Beginning at a point where the East (E) boundary of Gov't Lot Two (2) intersects with the South (S) right-of-way line of Sixth Street extended West across Trunk Highway 11-71; thence due North (N) along said East (E) boundary line of Gov't Lot Two (2) to the International Boundary line in Rainy River; thence West-Southwest (W-SW) along said International Boundary line to a point where the North (N) line of 6th Street extended, intersects with said International Boundary line; thence in an easterly direction along said North (N) line of 6th Street extended to a point where said extensions intersects with the present South (S) right-of-way of 6th Street; thence Southeasterly along said South (S) right-of-way line to the point of beginning:

Section III. That accordingly, said tracts of land described, herein, be and they hereby are, annexed to the City of International Falls and that said tracts of land hereby are a part of and subject to the jurisdiction of the City of International Falls, Minnesota.

Section IV. This Ordinance shall take full force and effect Thirty (30) days from and after its passage, approval and publication.
