AN ORDINANCE ANNEXING TERRITORY
TO THE CITY OF MONTEVIDEO

WHEREAS, petitions have been filed with the City of Montevideo by all the owners of the hereinafter described tracts of land requesting that said tracts of land be annexed to the City of Montevideo; and

WHEREAS, copies of said petitions have been filed with the municipal commission of the State of Minnesota, the Town Board of Sparta Township and the County Board of Chippewa County, and more than sixty (60) days have elapsed since such filing; and

WHEREAS, no objections to the annexation of said territory to the City of Montevideo have been received;

THE CITY OF MONTEVIDEO DOES ORDAIN:

1. That the City Council of the City of Montevideo finds and determines:

a. That the hereinafter described tracts of land abut upon the city limits of the City of Montevideo and are suburban in character and are susceptible to municipal control and development by the City of Montevideo.

b. That the annexation of the hereinafter described tracts of land will be to the best interest of the City of Montevideo and the territory affected thereby.

2. That those certain tracts of land in the County of Chippewa and State of Minnesota described as follows:

A tract of land in Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West of the Fifth Principal Meridian, described as commencing at a point on the west line of said Section Eight (8) which is One Thousand One Hundred Fifty-eight Feet (1,158') south of the northwest corner of said Section Eight (8), running thence east at a right angle for a distance of Three Hundred Sixteen and four-tenths Feet (316.4'); thence south and parallel to the west line of said Section Eight (8) a distance of Two Hundred Twenty-five Feet (225'); thence west at a right angle for a distance of Three Hundred Sixteen and four-tenths Feet (316.4') to the west line of said Section Eight (8) and thence north along said west line a distance of Two Hundred Twenty-five Feet (225') to the point of beginning, containing 1.6341 acres, more or less.

A tract of land in Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West of the Fifth Principal Meridian, described as commencing at a point on the west line of said Section Eight (8) which is One Thousand Six Hundred and Eight Feet (1,608') south of the northwest corner of said Section Eight (8), running thence east at a right angle for a distance of Three Hundred Sixteen and four-tenths Feet (316.4'); thence south and parallel to the west line of said Section Eight (8) a distance of Seventy-five Feet (75'); thence west at a right angle for a distance of Three Hundred Sixteen and four-tenths Feet (316.4') to the west line of said Section Eight (8), and thence north along said west line a distance of Seventy-five Feet (75') to the point of beginning, containing .5447 acres, more or less.

A tract in the North Three-Quarters (N 3/4) of the Northwest Quarter of Section Eight (8), Township One Hundred Seventeen (117), Range Forty (40), more particularly described as: Beginning at a point One Thousand Six Hundred Eighty-three Feet (1,683') south and Two Hundred Fifteen Feet (215') east of the northwest corner of Section Eight (8), Township One Hundred Seventeen (117), Range Forty (40), as measured along and at right angles to the west line of said Section Eight (8); thence south at right angles a distance of One Hundred Sixty-five Feet (165'); thence east at right angles a distance of One Hundred Forty-seven Feet (147'); thence north at right angles a distance of One Hundred Sixty-five Feet (165'); thence West at right angles a distance of One Hundred Forty-seven Feet (147') to the point of beginning, containing .5568 acres, more or less.

be and the same hereby are annexed to and incorporated into the corporate limits of the City of Montevideo.

3. This ordinance shall take effect thirty (30) days from and after its passage and publication.

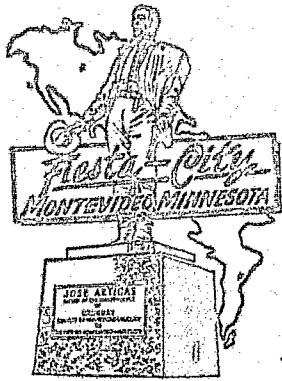

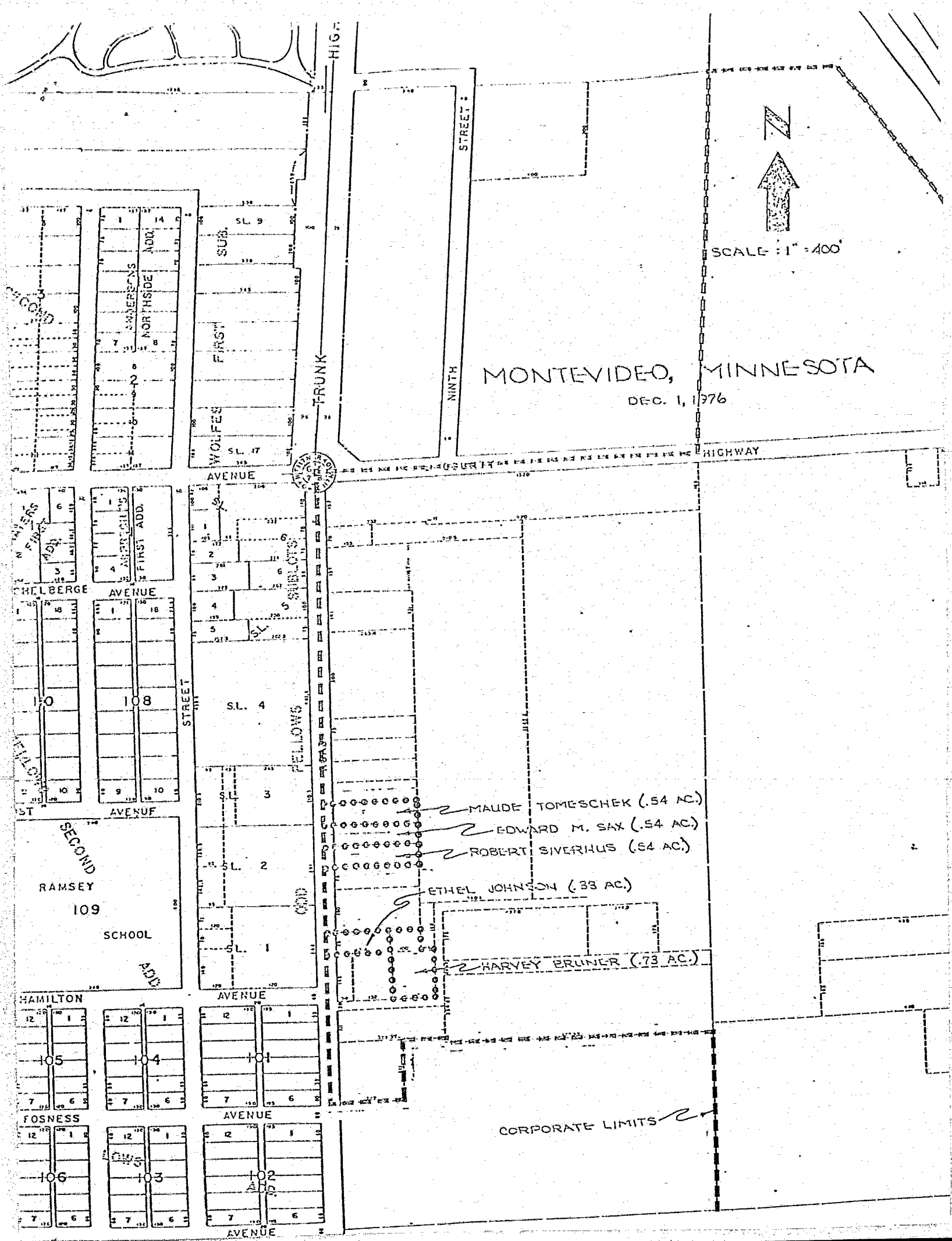
