

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF CROOKSTON TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition, requesting annexation of the territory hereinafter described was duly filed with the City Clerk of the City of Crookston; and

WHEREAS, the said petition was duly presented to the City Council of the City of Crookston on the 22nd day of March, 1977; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described, is less than 200 acres of unplatted land, all belonging to the Diocese of Crookston, Minnesota, and no part thereof being included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by the President and Secretary-Treasurer of the Diocese of Crookston, Minnesota, which is the sole owner of said land; and

WHEREAS, said petition for annexation was duly served upon the Chairman of the Crookston Township Board, the Secretary of the Polk County Board of Commissioners, and the Minnesota Municipal Commission; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any other municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the limits of the City of Crookston at the northeasterly boundary thereof;

NOW THEREFORE, BE IT ORDAINED by the City of Crookston as follows:

SECTION 1: The City Council hereby determines (1) that the annexation will be to the best interest of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

SECTION 2: Territory Annexed: The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

In the County of Polk and State of Minnesota, and described as follows, to-wit:

Beginning at a point on the Easterly line of the Northeast Quarter (NE $\frac{1}{4}$) of Section Thirty (30), Township One Hundred Fifty (150), North of Range Forty-six (46), West of the Fifth Principal Meridian, said point being the intersection of the North line of Fourth Avenue Northeast, a platted street in Grand View Place, an addition to the City of Crookston, Minnesota, if the same were extended Easterly to said Section line, and said Easterly line of said NE $\frac{1}{4}$; thence Northerly along said Easterly line a distance of 350.0 feet to a point, which point is the commencement of the property herein conveyed; thence Westerly parallel to the Northerly line of said 4th Avenue Northeast a distance of 683.0 feet; thence Northerly parallel to the Easterly line of said NE $\frac{1}{4}$ and 683.0 feet distant therefrom, a distance of 1500.0 feet; thence Easterly parallel to said 4th Avenue Northeast a distance of 683.0 feet to the East line of said NE $\frac{1}{4}$; thence Southerly along said East line a distance of 1500.0 feet to the point of commencement, containing 23.52 acres, more or less, according to the United States Government Survey thereof.

SECTION 3: Filing: The City Clerk is hereby directed to file certified copies of the Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor of Polk County, Minnesota.

SECTION 4: Effective Date: This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.

Upon the call of Ayes and Nays, the vote stood as follows:
