ORDINANCE NO. 19, SECOND SERIES

AN OLDINANCE OF THE CITY OF LITTLE FALLS EXTENDING THE COMPONATE LIMITS OF THE CITY OF LITTLE FALLS TO INCLUDE CERTAIN UNINCOMPONATED, UNPLATTED LAND NOT EXCELDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS AND AMENDING CITY CODE, SECTION 11.05, SUBD. 2, BEING THE ZONING MAP OF THE CITY OF LITTLE FALLS.

WHEREAS, a certain petition dated March 1, 1977, regarding the annexation of the territory hereinafter described and was duly presented to the Council on the 14th day of March, 1977, and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 1,500 square feet more or less of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough, and

WHEREAS, the petition was signed by all owners, and
WHEREAS, said petition requested that said property be zoned
B-2 (General Business District) upon its annexation, and

WHEREAS, the Little Falls City Council adopted Resolution 1977-15 approving the annexation of the land described in the petition, and

WHEREAS, no objection to the annexation has been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed, and

WHEREAS, the land described in the petition abuts upon the City limits at the easterly boundary thereof,

THE CITY OF LITTLE FALLS ORDAINS:

Section 1. The City Council hereby determines: (1) that the annexation will be in the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included with the City as effectually as if it had originally been a part thereof:

the territory to be annexed consists entirely of unplatted land,

all of these land lie entirely within the County of Morrison, State of Minnesota, and the description of such lands is as follows:

Lot Two (2), Block One (1), Wielinski First Addition, and Lot Two (2), Block One (1), Wielinski Second Addition.

Section 3. That the City Code, Section 11.05, Subd. 2, be and hereby is, amended by adding to the boundaries of General Business District (B-2), delineated on the Zoning Map of the City of Little Falls, which map is a part of said Section of the City Code, the following described premises situated in the City of Little Falls, County of Morrison, and State of Minnesota, to wit:

Lot Two (2), Block One (1), Wielinski First Addition, and Lot Two (2), Block One (1), Wielinski Second Addition.

Section 4. The Zoning Administrator shall cause the Zoning Map of the City of Little Falls to be changed and amended so as to show the amendment as provided in Section 3 hereof.

Section 5. This ordinance shall be added to Chapter 13 of the City Code under annexation and under Zoning Map Amendments.

Section o. Filing. The City Administrator is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Little Falls Town Clerk, the Morrison County Auditor and the Secretary of State.

Section 7. Effective Date. This ordinance shall be in full force and effect seven (7) days after its publication.
