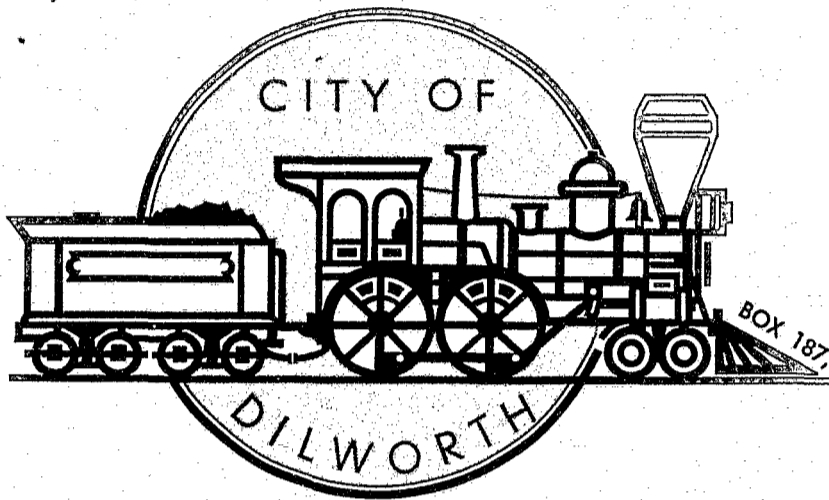

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF DILWORTH, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS a certain petition requesting annexation of the territory hereinafter described was duly presented to the Council on the 11th day of April, 1977; and

WHEREAS the quantity of land embraced within the area described in the petition and bounded as described is 62.09 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or brough; and

WHEREAS the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS the land described in the petition abutts upon the city limits at the Southwest boundary thereof; the Council of the City of Dilworth Minnesota ordains:

Section 1. The City Council hereby determines (1.) that the annexation will be to the best interests of the city and of the territory affected; (2.) that the territory described herein abutts upon the city limits and is or is about to become urban or suburban in character; and (3.) that none of said territory is now included within the limits of any city, village, or brough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had orginally been a part thereof:

Outlot A-11 in Section Eleven (11), Township One Hundred Thirty-nine (139), Range Forty-eight (48), consisting of 62.09 acres, Clay County Minneosta.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Municipal Commission, Secretary of State, and the County Auditor.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
