

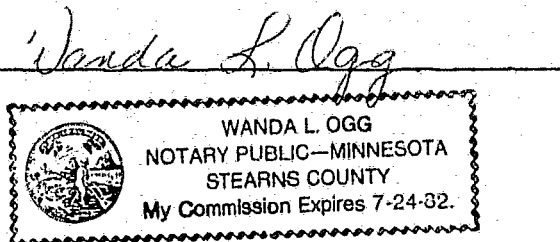

EXTRACT OF MINUTES OF MEETING OF  
THE CITY COUNCIL OF THE CITY OF  
WATKINS, MEEKER COUNTY, MINNESOTA

A regular meeting of the City Council of the City of Watkins, Meeker County, Minnesota, was held at the City Hall in said city on Wednesday, the 8th day of October, 1975, commencing at 7:30 o'clock, P.M.

The following members were present: William Haggerty, Verlin Mies, Hjalmer Hokanson, Eileen Spoden, and Robert Weber.

Robert Weber reported to the council that Attorney Kirby A. Dahl had served notice of the petition for annexation of land to the city, which had been submitted to the council by Joseph F. Hierlmaier et al, by mailing copies of the petition on September 5, 1975, to the Meeker County Board of Commissioners, addressed to the Meeker County Auditor; the Forest Prairie Town Board, addressed to Douglas Winings, Clerk of Forest Prairie Township; and to the Minnesota Municipal Commission, and that no objection to the petition had been filed by any of said bodies with either the Mayor, Clerk or the City Attorney, and that the City Attorney had received acknowledgment from the Minnesota Municipal Commission stating the petition was in order, and that the Town Board of Forest Prairie Township has waived objection to the annexation and waived the sixty (60) day time limit before an ordinance could be adopted.

Thereupon, Councilman Haggerty introduced the following resolution and moved its adoption:

RESOLUTION ADOPTING AN ORDINANCE EXTENDING  
THE CORPORATE LIMITS OF THE CITY OF WATKINS TO  
INCLUDE UNPLATTED LANDS ABUTTING UPON THE  
CITY LIMITS.

BE IT RESOLVED By the City Council of the City of Watkins, Minnesota, the following ordinance is hereby adopted as Ordinance No. 91, the Mayor and Clerk are hereby authorized to sign the same, and the Clerk is directed to make arrangements for publication of the same in The Patriot, to-wit:

ORDINANCE NO. 91

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WATKINS TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition, dated September 2, 1975, requesting annexation to the territory hereinafter described was duly presented to the council on the 2nd day of September, 1975, and

WHEREAS, the quantity of land embraced with the area described in the petition and bounded as described is approximately 14.93 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the petition was signed by all the owners of said land, and

WHEREAS, the Town Board of Forest Prairie Township has waived objection to the annexation of the land hereinafter described, and waived the sixty (60) day time limit before this ordinance could be adopted, and

WHEREAS, no objections to the annexation have been received from the Meeker County Board of Commissioners or the Minnesota Municipal Commission, said bodies having due notice as provided by statute, and

WHEREAS, the land described in the petition abuts the city limits at the North and West boundaries thereof,

NOW THEREFORE, THE COUNCIL OF THE CITY OF WATKINS, MINNESOTA, ORDAINS:

Section 1. The city council hereby determines (1) that the annexation will be in the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

That part of the West One-half of the Northeast Quarter ( $W\frac{1}{2} NE\frac{1}{4}$ ) of Section Two (2), Township One Hundred Twenty-one (121), Range Thirty (30), Meeker County, Minnesota, described as follows: Beginning at the Southwest corner of said  $W\frac{1}{2} NE\frac{1}{4}$ ; thence East along the South line of said  $W\frac{1}{2} NE\frac{1}{4}$ , a distance of 590.00 feet to the West line of Lot 8, Block 2, of Kramer's Addition, Auditor's Re-Plat to the City of Watkins, according to the recorded plat thereof; thence North along a West line of said Kramer's Addition, Auditor's Re-Plat to the City of Watkins, a distance of 174.00 feet; thence East along a North line of said Kramer's Addition, Auditor's Re-Plat to the City of Watkins a distance of 191.00 feet to a West line of said Kramer's Addition, Auditor's Re-Plat to the City of Watkins; thence North, along said West line, along the West line of Block 5, Kramer's Addition, Auditor's Re-Plat to the City of Watkins, and along the West line of Donnay Heights, according to the recorded plat thereof, a distance of 803 feet; thence West, deflecting left  $90^{\circ}05'$  a distance of 80.00 feet; thence Westerly along a tangential curve concave Southerly having a radius of 396.89 feet and a central angle of  $28^{\circ}17'$  a distance of 195.92 feet; thence Southwest, tangent to said curve, a distance of 141.90 feet; thence Westerly along a tangential curve concave Northerly having a radius of 395.50 feet and a central angle of  $28^{\circ}22'45''$  a distance of 195.89 feet; thence West, tangent to said curve, a distance of 199.98 feet to the West line of said  $W\frac{1}{2} NE\frac{1}{4}$ ; thence South, along said West line, a distance of 815.50 feet to the point of beginning. Containing 14.93 acres.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Meeker County Auditor, and the Clerk of the Township of Forest Prairie.

Section 4. Effective Date. This ordinance takes effect upon its passage, publication, and the filing of the certified copies as directed in Section 3.

The motion for the adoption of the foregoing resolution was duly seconded by Councilwoman Spoden, and upon vote being taken thereon, the following voted in favor thereof: William Haggerty, Verlin Mies, Hjalmer Hokanson, Eileen Spoden, and Robert Weber,
