A PARCEL OF LAND IN THE NE<sup>1</sup>/<sub>4</sub> OF SECTION 9, TOWNSHIP 115 NORTH, RANGE 41 WEST, COUNTY OF YELLOW MEDICINE, STATE OF MINNESOTA DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF LOT ONE, BLOCK ONE, MALON'S FIRST ADDITION TO THE CITY OF CLARKFIELD; THENCE EAST ALONG THE SOUTH RIGHT OF WAY LINE OF TRUNK HIGHWAY 67 AS NOW LOCATED IN SAID NE<sup>1</sup>/<sub>4</sub> A DISTANCE OF 800.00 FEET; THENCE SOUTH AT RIGHT ANGLES TO SAID RIGHT OF WAY LINE A DISTANCE OF 310.00 FEET; THENCE SOUTHWESTERLY A DISTANCE OF 1370.00 FEET, MORE OR LESS, TO A POINT ON THE EAST RIGHT OF WAY LINE EXTENDED SOUTHERLY OF FIFTH STREET (FORMERLY ALICE STREET) AS NOW LAID OUT AND PLATTED IN THE CITY OF CLARKFIELD THAT IS 660.00 FEET SOUTH OF THE SOUTHWEST CORNER OF LOT 4, BLOCK 2, OF SAID MALON'S FIRST ADDITION; THENCE NORTH ALONG THE SAID EAST RIGHT OF WAY LINE OF SAID FIFTH STREET A DISTANCE OF 640.00 FEET TO A POINT 20.00 FEET SOUTH OF THE SOUTHWEST CORNER OF SAID LOT 4, BLOCK 2; THENCE EAST ALONG A LINE THAT IS 20.00 FEET SOUTH OF THE SOUTHWEST CORNER OF SAID LOT 4, BLOCK 2; THENCE EAST ALONG A LINE THAT IS 20.00 FEET SOUTH OF AND PARALLEL TO THE SOUTH LINE OF SAID BLOCK 2 A DISTANCE OF 300.00 FEET; THENCE NORTH ALONG THE EAST LINE OF SAID MALON'S FIRST ADDITION A DISTANCE OF 512.00 FEET TO THE POINT OF BEGINNING.


