

DECLARATION AND CONSENT OF WAHPOTON BROCKENRIDGE STREET RAILWAY COMPANY  
THAT ITS FRANCHISE IS TO BE " INDETERMINATE PERMIT " UNDER CHAPTER 278  
OF THE LAWS OF MINNESOTA FOR YEAR OF 1921.

KNOW ALL MEN BY THESE PRESENTS: That, Whereas, The City of Brockenridge  
in the county of Wilkin and State of Minnesota, has heretofore granted the  
Wahpton Brockenridge Street Railway Company, a franchise known as Ordinance  
Numbered 48 which is hereby referred to for more certainty and particularity  
as to its terms and conditions: and, Whereas, it is the desire of said  
grantee, said Wahpton Brockenridge Street Railway Company, that said franchise  
so granted to it as aforesaid, shall from this time henceforth be and become  
an indeterminate permit pursuant to the authority in and provisions of Chapter  
278 of the laws of Minnesota for the year of 1921, and makes this declaration  
and consent accordingly:

Now, ~~that~~ <sup>Be it Resolved, that</sup> ~~therefore,~~ pursuant to the authority in and the provisions of said Act,  
Chapter 278 of the Session Laws of Minnesota for the year of 1921, said  
Wahpton Brockenridge Street Railway Company does hereby and herein make its  
written declaration that it desires that such grant, to-wit: said franchise  
known and described as Ordinance Numbered 48 of the Ordinances of the said  
City of Brockenridge, Minnesota, shall become an indeterminate permit to it,  
the said grantee, and does hereby consent that the terms of said Act shall  
apply to and govern the ownership, control, management, maintenance and  
operation of the street railway property of said Wahpton Brockenridge  
Street Railway Company.

Be It Further Resolved, that this Declaration and Consent, be filed  
with the City Clerk of The said City of Brockenridge, Minnesota, pursuant to said  
Act, to the end and purpose that he may issue to said Wahpton Brockenridge Street  
Railway Company a certificate that such Declaration and Consent has been filed in  
his office,
