AN ORDINANCE ANNEXING UNPLATTED LAND IN SECTION 18 (SUNNYSLOPE)

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the Council on June 27, 1977; and

WHEREAS, the quanity of land embraced with in the area described in the petition is 5.90 acres of unplatted land, no part of which is included within the limits of any incorporated city; and

WHEREAS, the petition was signed by all owners of property included; and

WHEREAS, no objections to the annexation have been received from the town board, and the town board has waived in writing its right to consider the matter 60 days, and no municipality abuts upon the boundaries of the land petitioning for annexation; now, therefore,

THE CITY OF ALBERT LEA DOES ORDAIN:

Sec. 1. The City Council hereby determines that annexation of the territory hereinafter described will be in the best interests of the City and of the territory affected, that the territory described abuts upon the City Limits and is about to become urban or suburban in character, and that none of said territory is now included within the limits of any city.

Sec. 2. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:
