Pursuant to Minnesota Statutes, 1976, Section 16.125 and 16.135, the following administrative reorganization is made.



- (b) For nonmedical and health services research grants: \$300,000 to be transferred from the Department of Health (40400:02-10) to the State Planning Agency (12002:22-10)
- (c) For health policy studies: \$200,000 to be transferred from the Department of Health (40400:03-10) to the State Planning Agency (12002:23-10)




