Ordinance Number 1977-1

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ALBANY, STEARNS COUNTY, MINNESTOA, TO INCLUDE CERTAIN UN-INCORPORATED, UNPLATTED LAND NOT EXCEEDING 200 ACRES ABUTT-ING UPON THE CITY LIMITS

WHEREAS, a petition requesting annexation of the territory herein described <sub>WAS</sub> duly served upon the Clerk of the said City on the 18th day of April, 1977; and

WHEREAS, the quanity of land described in the said petition is unplatted, less than 200 acres in area and not included within the limits of any other City; and

WHEREAS, the petition was signed by all of the owners, and WHEREAS, no objections to the annexation have been received from the Albany Town Board, the Stearns County Board Of Commissioners, or the governing whose boundries abut upon the land to be annexed, and

WHEREAS, the land described in the petition abuts the City of Albany on its Easterly boundary; therefore

THE CITY COUNCIL OF THE CITY OF ALBANY, STEARNS COUNTY, MINNESOTA, ordains:

SECTION I. The City Council hereby determines

- 1. That the annexation is in the best interest of the City and the territory annexed
- 2. That the territory described herein abuts upon the city limits and is about to become urban in character
- 3. That none of the territory to be annexed is now within the limits of any other city.

SECTION II. Territory Annexed.

The Corporate limits of the City of Albany are hereby extended to include the unplatted land described herein and the same is hereby annexed to and included within the City as if it had been originally a part thereof:

## Area To Be Annexed:

All of that part of the Northwest Quarter of the Southeast Quarter (NV<sub>4</sub>SE<sub>4</sub>) of Section 15 of Township 125 North; Range 31 West in Stearns County, Minnesota and described as follows:

.46 Acres of the S2NW4SE4: beginning 305' East and 100' South of the Southwest Corner of Lot 7 of Auer's Addition; thence South 100'; thence West 200'; thence North 75.5'; thence North 42 degrees West 29'; thence East 215' to the beginning.

The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Minnesota Secretary Of State, the Stearns County Auditor and the Albany Township Board.

SECTION IV. Effective Date


This Ordinance takes effect upon its passage, publication and filing as directed in SECTION III of this Ordinance.
