ORDINANCE NO. 1300

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO IECLUDE CHRAIN UNINCORPORATED TERRITORY AT LEAST STATY PERCENT (60%) SURROUNDED BY LAND WITNIE THE CITY LIMITS AND ADUPTING THEREON.

Wilhiams, certain territory described below is not presently included within the Corporate Limits of any Incorporated City, Village, or Dozough,

AND, WHEREAS, this territory is at least sixty percent (60%) surrounded on all sizes by land already included within the Corporate Limits of the City and is decred to be urban in character.

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

SECTION ONE:

Territory annexed. The Corporate Limits of the City of Austla, Minnesota, are hereby entended to include a territory described as Sollows, which territory now is and has heretofore been at least sinty percent (60%) surrounded by territory already included within the City Limits:

Beginning at the northeast corner of the S'; of the BWG of Section 34, Township 103 Morth, Range 18 West, Mover County, Minn sota; thence southerly along the east line of said WWG to the southeast corner of the BWG of Section 34; thence westerly along the south line of said & section, this line also being the north right-of-way line of Interstate Righway No. 90, to a point 348 feet cast of the southwest corner of the BWG of said Section 34; thence cortherly on a line parallel to the west line of said & section to the north line of the S' of the BWG; thence costorly along the north line of the S' of the BWG; the BWG to the point of beginning.

Approximately 70.3 acres.

SECTION TWO:

Filing. The City Recorder is directed to file certified copies of this Ordinance with the Secretary of State, County Auditor of the County in which the property is located, the Township Clork of the Township in which the property is located, and Minnesota Municipal Commission, Austin Utilities, and Registrar of Doeds.

SECTION THREE:

Effective Date of Annexation. This Ordinance takes affect upon passage and publication and filing the certified copies as directed in Section Two.
