ORDINANCE NO. 1308

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY AT LEAST SIXTY PERCENT (60%) SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the Corporate Limits of any Incorporated City, Village, or Borough,

AND, WHEREAS, this territory is at least sixty percent (60%) surrounded on all sides by land already included within the Corporate Limits of the City and is deemed to be urban in character.

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

SECTION ONE:

Territory annexed. The Corporate Limits of the City of Austin, Minnesota, are hereby extended to include a territory described as follows, which territory now is and has heretofore been at least sixty percent (60%) surrounded by territory already included within the City Limits:

Beginning at the northeast corner of the S $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Section 34, Township 103 North, Range 18 West, Mower County, Minnesota; thence southerly along the east line of said NW $\frac{1}{4}$ to the southeast corner of the NW $\frac{1}{4}$ of Section 34; thence westerly along the south line of said $\frac{1}{4}$ section, this line also being the north right-of-way line of Interstate Highway No. 90, to a point 348 feet east of the southwest corner of the NW $\frac{1}{4}$ of said Section 34; thence northerly on a line parallel to the west line of said $\frac{1}{4}$ section to the north line of the S $\frac{1}{2}$ of the NW $\frac{1}{4}$; thence easterly along the north line of the S $\frac{1}{2}$ of the NW $\frac{1}{4}$ to the point of beginning.

Approximately 70.3 acres.

SECTION TWO:

Filing. The City Recorder is directed to file certified copies of this Ordinance with the Secretary of State, County Auditor of the County in which the property is located, the Township Clerk of the Township in which the property is located, and Minnesota Municipal Commission, Austin Utilities, and Registrar of Deeds.

SECTION THREE:

Effective Date of Annexation. This Ordinance takes effect upon passage and publication and filing the certified copies as directed in Section Two.
