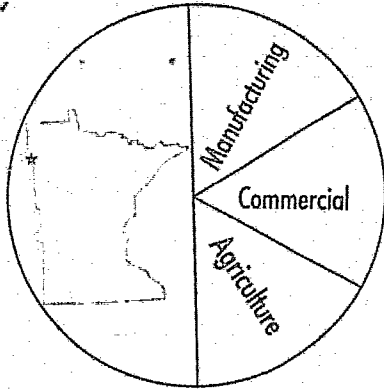

## ORDINANCE NO. 138 2ND SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS, TO INCLUDE CERTAIN UNPLATTED LANDS IN SECTION 7, TOWNSHIP 151, NORTH, RANGE 49 WEST OF THE 5TH PRINCIPAL MERIDIAN, POLK COUNTY, MINNESOTA, NOT EXCEEDING 200 ACRES, WHICH TRACT CONTAINS 47 ACRES, MORE OR LESS.

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by S.F.S., Inc., being the owners of the land hereinafter described, to have such land included within the City Limits of the City of East Grand Forks, Minnesota, that copies of said petition were filed with the Minnesota Municipal Commission, the Town Board of Grand Forks Township and the County Board of Polk County, Minnesota; that more than sixty (60) days have elapsed since such filings of said petition, and that no objections have been filed as is more fully shown by the records and files herein.

Section 2. That the tract of land being annexed is described as follows, to-wit:

Government Lot Three (3); that part of Government Lot Four (4) containing 9.47 acres, more or less, described as follows: beginning at a point on the West line of Section Seven (7); 990 feet North of the Southwest corner of Section Seven (7); thence running East 1253.75 feet to the subdivision line, thence running North on the subdivision line 330 feet, thence West on the subdivision line 1256 feet to the West line of Section Seven (7), thence South on the Section line of Section Seven (7) 330 feet, to the place of beginning, all in Section Seven (7), Township One Hundred Fifty-one (151) North, Range Forty-nine (49) West

Section 3. That the quantity of said land herein described is 47 acres, more or less.

Section 4. That the City Council hereby determines:

1. That the quantity of land embraces within the foregoing description is less than 200 acres.

2. That the annexation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected.

3. That the territory and land described above abuts the City of East Grand Forks, Minnesota, is suitably conditioned for municipal government, and is urban in character.

4. That the petition for annexation was signed by all of the owners of the owners of the land and real estate hereinabove described.

Section 5. The corporate limits of the City of East Grand Forks, Minnesota, are hereby extended to include the property described in Section 2, and the same is hereby annexed to and included in the City of East Grand Forks, Minnesota, as effectively as if had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this Ordinance with the State of Minnesota Municipal Commission, the County Auditor, the Town Clerk and the Secretary of the State of Minnesota.

Section 7. This Ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 6, and be given the number 138, 2ND SERIES.
