

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS, TO INCLUDE CERTAIN UNPLATTED LANDS IN SEC-TION 7, TOWNSHIP 151, NORTH, RANGE 49 WEST OF THE 5TH PRINCIPAL MERIDIAN. POLK COUNTY, MINNESOTA, NOT EX-CEEDING 200 ACRES, WHICH TRACT CONTAINS 47 ACRES, MORE OR LESS. The City Council of the City of East Grand Forks, Minnesota, do ordain: Section 1.
