CITY OF EVANSVILLE ORDINANCE #71

ANNEXATION OF NELSON'S 2ND ADDITION TO THE CITY OF EVANSVILLE

WHEREAS, the following described real estate is adjacent to the city limits of the City of Evansville, and

WHEREAS, the legal description is as follows:

A part of Government Lot Three (3), Section Three (3), Township One Hundred Twenty-nine (129) North, Range Forty (40) West of the 5th P. M., being more particularly described as follows, to wit: Beginning at the Southwest corner of Lot Eleven (11), Block Three (3), "NELSON'S ADDITION TO VILLAGE OF EVANSVILLE"; thence from the point of beginning and following along the Northerly line of State Street extended, thus: S89°46'W 193.07 ft.; thence S84°26'W 341.48 ft.; thence leaving said Northerly line of State Street extended S00°14'E 553.00 ft.; thence N89°46'E 550.90 ft.; thence N01°26'30"W 516.25 ft. to the intersection with the Southerly line of said State Street extended; thence N89°46'E and along said Southerly line of State Street extended 73.80 ft. to the intersection with the East line of said Government Lot 3; thence N01°05'W and along said East line 66.01 ft. to a point on the South line of said Lot 11, Block 3, "NELSON'S ADDITION TO VILLAGE OF EVANSVILLE"; thence S89°46'W and along said South line of Lot 11, a distance of 72.82 ft. to the point of beginning and containing 7.18 acres more or less.

The above described property is the perimeter boundary of the future plat of "NELSON'S 2ND ADDITION TO THE CITY OF EVANSVILLE", and

WHEREAS, all owners of said real estate have petitioned the City Council to annex said real estate, and

WHEREAS, no objections have been received to such annexation, and

WHEREAS, it is in the best interests of the City of Evansville and the territory affected to have said land annexed to the City of Evansville.

NOW, THEREFORE, BE IT ORDAINED that the real estate in Nelson's Addition above described is hereby annexed to the City of Evansville by the resolution and ordinance of the Evansville City Council pursuant to Minnesota Statute 414.033. This ordinance shall take effect upon its adoption and publication.
