ANNEXATION OF PART OF NELSON'S ADDITION

WHEREAS, the following described real estate is adjacent to the city limits of the City of Evansville, and

WHEREAS, the legal description is as follows: all of the real estate which lies west of the north-south half-section line in the middle of Section 3, Township 129, Range 40 being a part of Nelson's Addition to the City (formerly Village) of Evansville, and

WHEREAS, all owners of said real estate have petitioned the City Council to annex said real estate, and

WHEREAS, no objections have been received to such annexation, and

WHEREAS, it is in the best interests of the City of Evansville and the territory affected to have said land annexed to the City of Evansville.

NOW, THEREFORE, BE IT ORDAINED that the real estate in Nelson's Addition above described is hereby annexed to the City of Evansville by the resolution and ordinance of the Evansville City Council pursuant to Minnesota Statute 414.033. This ordinance shall take effect upon its adoption and publication.
