ORDINANCE NO. 78

AN ORDINANCE PROVIDING FOR ANNEXATION OF CERTAIN REAL PROPERTY PURSUANT TO MINNESOTA STATUTES, SECTION 414,033, SUBDIVISION 5.

WHEREAS, a certain Petition dated the <u>16th</u> day of <u>May</u>, 1977, requesting annexation of the real property described below, was duly presented to the Council and filed in the office of the City Clerk on May 16, 1977; and

WHEREAS, said Petition for Annexation was duly signed by all of the owners of the property described below; and

WHEREAS, a true and correct copy of said Petition for Annexation has been filed with the Isanti County Board on the 18th day of May, 1977, and the Town Board of the Township of Isanti; and

WHEREAS, more than sixty (60) days have elapsed since said Petition for Annexation has been duly filed, and other legal requirements as to filing and certification have been met, and no objections to said annexation have been made or filed with the Minnesota Municipal Commission or the City of Isanti; and

WHEREAS, the real property described below does not exceed two hundred (200) acres and abuts the City of Isanti; and

WHEREAS, the City Council has determined that the annexation of the real property described below will be to the best interests of the City of Isanti and of the property affected, NOW, THEREFORE, the City Council of Isanti ordains: 14.001 ※「「新知道」」を行うたい。

Section 1. The real property described as follows, to-wit:

That part of the Northeast Quarter of the Southwest Quarter (NE 1/4 of SW 1/4) of Section Thirty (30), Township Thirty-five (35), Range Twenty-three (23), described as follows: Commencing at the Northwest corner of said NE 1/4 of SW 1/4 for the actual point of beginning of the tract of land to be herein described: Thence due East along the North line of said NE 1/4 of SW 1/4 and the centerline of County State Aid Highway Number 5 a distance of 643.15 feet; thence S02020'57" along the centerline of County State Aid Highway Number 23 a distance of 589.13 feet; thence due West and parallel with the North line of said NE 1/4 of SW 1/4 a distance of 603.57 feet to a point on the West line of said NE 1/4 of SW 1/4; thence NO1^O30'06"W along said West line a distance of 588,84 feet to the actual point of beginning. Subject to easement for public highway over and across the North 33 feet thereof and the Easterly 40 feet thereof, and easements of record, if any.

Section 2. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance in the office of the Minnesota Municipal Commission, the Clerk of the Township of Isanti, the office of the Isanti County Auditor, and the office of the Secretary of State of the State of Minnesota.

Section 3. Effective Date of Annexation. Annexation of the above-described real property shall be complete from and after the date when certified copies of this ordinance have been filed as directed in Section 2 hereof.
