

ORDINANCE NO. 670

An Ordinance Extending the corporate limits of the City of Willmar, a Municipal Corporation of the State of Minnesota, to include certain lands not exceeding 200 acres

WHEREAS, A petition has been filed with the governing body of the City of Willmar, a Municipal Corporation in the State of Minnesota by the sole owner having any interest therein, to have certain real property, hereinafter described, included within the limits of the City of Willmar, Minnesota, and

WHEREAS, It is proposed to annex by virtue hereof to the said City of Willmar, said property, all of which said property is in Kandiyohi County in the State of Minnesota, and

WHEREAS, The said property to be annexed consists of approximately 38.18 acres described as follows:

A tract of land lying and being in the County of Kandiyohi, State of Minnesota, described as follows, to-wit:

That part of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of Section Eight (8), Township One Hundred Nineteen (119), Range Thirty-Five (35), lying northerly of the right-of-way of the Great Northern Railway Company as the same is located over and across said Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$  of SE $\frac{1}{4}$ ), Kandiyohi County, Minnesota; Subject to a County Road Easement over the Easterly 75.00 feet.

NOW, THEREFORE, The City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. *Best Interest of City of Willmar and Area to be Annexed.* That the annexation will be to the best interests of the City of Willmar, Minnesota, and of the territory affected.

Section 2. *Abuts on City Limits.* That the property above described abuts on the City Limits, and is so conditioned as property to be subject to City government.

Section 3. *Annexation.* That the said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had originally been a part hereof.

Section 4. *Zoning.* The area above described shall be zoned R-2 and R-3, R-2 being Single Family Residential District and R-3 being Multiple Dwelling Residential District.

Section 5. *Effective Date.* This ordinance shall be filed and shall take effect and be at full force from and after filing a certificate hereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
