

ORDINANCE NO. 662

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota, to Include Certain Lands Not Exceeding 200 Acres.

WHEREAS, A petition has been filed with the governing body of the City of Willmar, a Municipal Corporation in the State of Minnesota, by the sole owner having any interest therein, to have certain real property, hereinafter described, included within the limits of the City of Willmar, Minnesota, and

WHEREAS, It is proposed to annex by virtue hereof to the said City of Willmar, said property, all of which said property is in Kandiyohi County in the State of Minnesota, and

WHEREAS, The said property to be annexed consists of approximately 10 acres described as follows:

The West 60 rods of the North 26 rods 11 feet of the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 13, Township 119, Range 35, Except the West 2 rods thereof.

NOW, THEREFORE, The City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. *Best Interest of City of Willmar and Area to be Annexed.* That the annexation will be to the best interests of the City of Willmar, Minnesota, and of the territory affected.

Section 2. *Abuts on City Limits.* That the property above described abuts on the City Limits, and is so conditioned as property to be subject to City government.

Section 3. *Annexation.* That the said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had originally been a part hereof.

Section 4. *Zoning.* The area above described shall be zoned R-3, Multiple Family Residential District.

Section 5. *Effective Date.* This ordinance shall be filed and shall take effect and be at full force and after filing a certificate hereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
