ORDINANCE NO. 661

An Ordinance Extending the Corporate limits of the City of Willman, a Municipal Corporation of the State of Minnesota, to Include Certain Lands Not Exceeding 200 Acres.

WHEREAS, A petition has been filed with the governing body of the City of Willmar, a Municipal Corporation in the State of Minnesota by the sole owner having any interest therein, to have certain real property, hereinafter described, included within the limits of the City of Willmar, Minnesota, and

WHEREAS, It is proposed to annex by virtue hereof to the said City of Willmar, said property, all of which said property is in Kandiyohi County in the State of Minnesota, and

WHEREAS, The said property to be annexed consists of approximately 11.6 acres described as follows:

The East 605 feet of the West 640 feet of the South 914.88 feet of the Southwest Quarter of the Southeast Quarter of Section 14, Township 119, Range 35, subject to road easements for Willmar Avenue over the southerly 50 feet thereof.

NOW, THEREFORE, The City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. Best Interest of City of Willmar and Area to be Annexed. That the annexation will be to the best interests of the City of Willmar, Minnesota, and of the territory affected.

Section 2. Abuts on City Limits. That the property above described abuts on the City Limits, and is so conditioned as property to be subject to City government,

Section 3. Annexation. That the said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had originally been a part hereof.

Section 4. Zoning. The area above described shall be zoned R-4, Multiple Family Residential District.

Section 5. Effective Date. This ordinance shall be filed and shall take effect and be at full force from and after filing a certificate hereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
