FINDINGS OF FACT, CONCLUSIONS OF LAW,

The above-entitled matter came on for hearing before the Minnesota Municipal Board pursuant to Minnesota Statutes 414, as amended, on April 11, 1977, at Brainerd, Minnesota, and was continued from time to time. The hearing was conducted by Robert Johnson, Vice Chairman, pursuant to Minnesota Statutes 414.01, Subd. 12. Also in attendance were County Commissioners Otto Schalow and Francis Murphy, ex-officio members of the Board. The City of Brainerd appeared by and through D. A. Larson, and Crow Wing Township was represented by Don Crust, township clerk. Testimony was heard and records and exhibits were received.

After due and careful consideration of all evidence, together with all records, files and proceedings, the Minnesota Municipal Board hereby makes and files the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. On August 6, 1976, a copy of a Notice of Intent to annex was filed with the Minnesota Municipal Board by the City of Brainerd. The Notice of Intent contained all the information required including a statement that the area proposed for annexation is 60 percent or more bordered by the city and a description of the territory subject to annexation which is as follows:

The South 335 feet of that part of the Southwest Quarter of the Southeast Quarter (SW_4SE_4), Section 36, Township 45 North, Range 31 West lying westerly of the westerly right-of-way line of the Burlington Northern Railway right-of-way and the South 335 feet of that part of the Southeast Quarter of the Southwest Quarter (SE_4SW_4), Section 36, Township 45 North, Range 31 West lying east of the right-of-way of trunk highway number 371.

An objection by Crow Wing Township to the proposed annexation was received by the Minnesota Municipal Board on September 15, 1976. The Municipal Board upon receipt of this objection set a date for hearing in accordance with M.S. 414.031, Subds. 3 & 4 as required by M.S. 414.033, Subd. 3. Prior to the hearing date, on November 17, 1976, Crow Wing Township exercised the township option clause contained in M.S. 414.034(2).

- 2. Due, timely and adequate legal notice of the hearing was published, served and filed.
 - 3. Geographic Features
 - a. The area subject to orderly annexation is unincorporated and abuts the City of Brainerd.
 - b. The total area of the City of Brainerd is 4,575 acres.

 The total area of the territory subject to orderly

 annexation is 17.4 acres.
 - c. The perimeter of the area subject to orderly annexation is 85 90% bordered by the municipality.
 - 4. Population Data
 - a. The City of Brainerd presently has about 12,000 persons and is growing.
 - b. The area subject to annexation

 - 5. Development Issues
 - a. What, if any, are the comprehensive plans for the

development of the property proposed for annexation and/or the annexing municipality, including development projected by the state planning agency? Region 5 is developing plans for the area.

 - b. In the area subject to orderly annexation, the assessed valuation is \$1,142,893, the mill rate is 10.76 and the present bonded indebtedness is none.
 - c. The mill rates in the following units of government are:

 - 2) School Districts 47.22
 - d. Will the orderly annexation have any effect upon area school districts? No.
- 8. Is orderly annexation to the City of Brainerd the best alternative.
 - a. Could governmental services be better provided for by incorporation of the area subject to orderly annexation?

 - b. Could governmental services be better provided for by

consolidation or orderly annexation of the area with an adjacent municipality other than Brainerd? No.

- c. Could Crow Wing Township provide the services required?

- d. Can Crow Wing Township continue to function without the area subject to orderly annexation? Yes.

9. Alteration of Boundaries

The area subject to designation for orderly annexation should be increased in order to include that property described in Municipal Board File A-3122 (Peterson property) and other property, all of which is urban or suburban or about to become so. The parties to this proceeding stipulated to the designation of said increased area. The entire area, including the increased area, is described as follows:

All of the NE¼NW¼ and SE¾NW¾, of Section 1, Township 44, Range 31, lying Northerly and Westerly of the Easterly and/or Southerly right-of-way for T.H. No. 371 except the part of said NE¼NW¼ lying Westerly of the Westerly right-of-way for said highway which lies South of the North 528 feet thereof and which lies East of the West five (5) acres of said NE¾NW¾, and, All that part of the South 335 feet of the SE¼SW¾ and the SW¼SE¾, Section 36, Township 45, Range 31, which lies Westerly of the Easterly right-of-way for the Burlington Northern Railroad right-of-way and which lies Easterly of the Westerly right-of-way line for the T.H. No. 371, Crow Wing County, Minnesota.

CONCLUSIONS OF LAW

- 1. The Minnesota Municipal Board duly acquired and now has jurisdiction of the within proceeding.
- 2. The area subject to orderly annexation is now or is about to become urban or suburban in character.
- 3. Municipal government is required to protect the public health, safety, and welfare in the area subject to orderly annexation.
- 4. The best interest of the City of Brainerd and the area subject to orderly annexation will be furthered by designation of the area.
- 5. The remainder of the Township of Crow Wing can carry on the functions of government without undue hardship.

- 6. Orderly annexation of all or a part of the property to an adjacent municipality would not better serve the interests of the residents who reside in the area subject to orderly annexation.
- 7. An order should be issued by the Minnesota Municipal Board designating the increased area for orderly annexation described herein.

ORDER

IT IS HEREBY ORDERED: That the following described property situated in the County of Crow Wing, State of Minnesota, be and the same is hereby designated for orderly annexation to the City of Brainerd, Minnesota.

> All of the NEWNW and SEWNW, of Section 1, Township 44, Range 31, lying Northerly and Westerly of the Easterly and/or Southerly right-of-way for T.H. No. 371 except the part of said NE½NW½ lying Westerly of the Westerly right-of-way for said highway which lies South of the North 528 feet thereof and which lies East of the West five (5) acres of said NE $\frac{1}{2}$ NW $\frac{1}{4}$, and, All that part of the South 335 feet of the SE $\frac{1}{4}$ SW $\frac{1}{4}$ and the SW4SE4, Section 36, Township 45, Range 31, which lies Westerly of the Easterly right-of-way for the Burlington Northern Railroad right-of-way and which lies Easterly of the Westerly right-of-way line for the T.H. No. 371, Crow Wing County, Minnesota.

IT IS FURTHER ORDERED: That the effective date of this order is November 8, 1977.
