ORDINANCE NUMBER 142

AN ORDINANCE TO ANNEX LAND TO THE
CITY OF BENSON

The City of Benson does ordain:

The real estate hereinafter described be and hereby is annexed to the City of Benson so that the same shall be a part thereof and within the geographical limits of the City of Benson as provided by the laws of the State of Minnesota and that it is in the best interests of the City of Benson and of the territory hereinafter described that it be annexed to the City of Benson, to-wit:

That part and parcel of land situate in the County of Swift, State of Minnesota described as follows: Beginning at a point 165 feet South and 150 feet East of the Northwest corner of the Southeast Quarter (SE $\frac{1}{4}$) of Section Five (5), Township One Hundred Twenty-one (121), Range Thirty-nine (39); thence South a distance of 165 feet; thence East to the East line of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ -SE $\frac{1}{4}$) of Section Five (5), Township One Hundred Twenty-one (121), Range Thirty-nine (39); thence North a distance of 165 feet; thence West to the place of beginning; and being a part of the North Half of the North Half of the Northwest Quarter of the Southeast Quarter (N $\frac{1}{2}$ -N $\frac{1}{2}$ -NW $\frac{1}{4}$ -SE $\frac{1}{4}$) of Section Five (5), Township One Hundred Twenty-one (121), Range Thirty-nine (39).
