ORDINANCE NO. 6.65

AN ORDINANCE ANNEXING CERTAIN PARCELS OF LAND TO THE CITY OF INTERNATIONAL FALLS AND PLACING THE SAME WITHIN THE JURISDICTION OF SAID CITY.

The City Council of the City of International Falls does ordain as follows:

SECTION I

That Eighty percent (80 per cent) of the following parcels of land are adjacent to the City of International Falls, Minn.

SECTION II

That after due consideration, the City Council has deemed it to be in the best interest of the City that said land be annexed to and become a part of said city, said property being described as follows:

That parcel of land lying in Government Lot Two (2), Section Five (5), Township Seventy (70) N., Range Twenty-four (24) W. of the Fourth Principal Meridian according to the United States Government Survey thereof, and being in the County of Koochiching, and the State of Minnesota, except as follows:

Resuming the East boundary thereof and Government Lot Two (2) to have a bearing of N. 0 degrees 22' 09" W., and starting at the intersection of the West right-of-way of 20th Avenue, the South boundary line of the Plat of Shorewood, thence southerly along the arc of a simple curve concave to the East which has a tangent bearing of South and a radius of 956.71 feet for a distance of 40.01 feet to the point of beginning, thence continuing southerly along the arc of said curve for a distance of 166.35 feet to the beginning of a simple curve concave to the West which has a radius of 861.32 feet and a tangent bearing of S. 12 degrees 73' 45" E., thence southerly along the arc of said curve for a distance of 136.40 feet to a point, thence S. 67 degrees 47' 00" E. for a distance of 150.00 feet to the point of beginning; and containing 1.16 acres more or less and excepting the property described in Exhibit A attached;

SECTION III

That accordingly, said tracts of land described herein be and they hereby are, annexed to the City of International Falls and that said tracts of land hereby are a part of and subject to the jurisdiction of the City of International Falls, Minnesota.

SECTION IV

This Ordinance shall take full force and effect Thirty (30) days from and after its passage, approval and publication.

EXHIBIT A

Blocks One (1), Two (2), Three (3) and Four (4) Plat of Shorewood and Beginning at the Northeast corner of Block Four (4) of the Plat of Shorewood; thence South 160 feet to the Southeast corner of said Block Four (4) of the Plat of Shorewood; thence East (E) to the West (W) line of the parking area for public access; thence North (N) along this line a distance of 160 feet; thence West (W) to the point of beginning, and less the public access to Rainy River and also annexing The East (E) 300 feet of Government Lot Three (3) of Section Five (5), Township Seventy (70), Range Twenty-four (24) lying South (S) of the Plat of Shorewood, Blocks Three (3) and Four (4) and also annexing that portion of 20th Avenue not presently in the city limits, North of Highway 11-7.
