AN ORDINANCE EXTENDING THE VILLAGE BOUNDARIES OF THE VILLAGE OF HIBBING, ST. LOUIS COUNTY, MINNESOTA SO AS TO INCLUDE WITHIN THE VILLAGE AND TO ANNEX THERETO THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER AND THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION THIRTY-TWO, TOWNSHIP FIFTY-FIGHT, RANGE TWENTY, IN ST. LOUIS COUNTY. MINNESOTA.

THE VILLAGE COUNCIL OF THE VILLAGE OF HIBBING. IN ST. LOUIS COUNTY, MILLESOTA DO ORDAIN AS FOLLOWS:

Section 1. The owners of the Northeast Quarter (NE 1/40 of the Southwest Quarter (SW 1/4) and the Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of Section Thirty-two (32), Township Fifty-eight (58), of Range Twenty (20), in St. Louis County, Minnesota, which is unplatted land and which land abuts upon the present limits of the village of Hibbing, having petitioned the village council of the village of Hibbing to have said land included within said village and amexed there to:

It is hereby ordained, enacted and declared that said tracts of land above described be and the same are hereby annexed to the said village of Hibbing, and the boundaries and corporate limits of said village of Hibbing are hereby extended so as to include said tracts of land, and said lands shall be and become a part of said village as effectually as if they had been originally a part there of.

Section 2. This ordinance shall take effect and be in force from/its passage and publication and the filing of a certified copy thereof with the Secretary of State.
