AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ANNANDALE TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated August 8, 1977, requesting annexation of the territory herinafter described was duly presented to the council on the 8th day of August, 1977; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 20 acres of unplatted land, no part of which is included within the limits of an incorporated city, or borough, and

WHEREAS, the petition was signed by all owners and

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the easterly boundary thereof;

WHEREAS, certain lands described in Section 2(c) are public lands by virtue continued use by the public of a road in accordance with Minnesota Statutes 160.05,

the council of the City of Annandale, Minnesota, ordains:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

- A. Ledwein property: The east 700 feet of the west  $916\frac{1}{2}$  feet of the S  $\frac{1}{2}$  of the SE $\frac{1}{2}$  of Sec. 29-121-27 except:
  - 1) The area south of the Soo Line Railroad right of way
  - 2) The area taken for State Highway purposes
- B. Rasset property: A tr. of land in Sec. 29-121-27 desc. as follows:

  Begin at a point on the N. line of Trunk Highway #55, 1 rod E. of the W.

  line of the SW % of the SE % of said Sec. 29; thence N. 1 rod E. of the W.

  line of said SW% of SE% and par. to said W. line of said SW% of SE% said

  Sec. 29, 400 ft. to a point, same being 1717.8 ft. S. of 1 rod E. of the

C. Public Road: A tract of land 60.0 feet in width being in the SW% and the SW2 of the SE2 of Section 29, Township 121, Range 27 Wright County, Minnesota, the centerline of said tract described as follows: Commencing at the southeast corner of said SWz, thence north along the east line of said SW4, a distance of 510.53 feet to the northwesterly right of way of Minnesota State Highway #55, thence northwesterly deflecting 630 32' 58" left along said northwesterly right of way line, a distance of 15.08 feet to the actual point of beginning of said centerline; thence north parallel with the east line of said SWk, a distance of 480.27 feet and there terminating. The side lines of said tract to be shortened or lengthened to begin at the northwesterly right of way line of State Highway #55.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
