ORDINANCE NO. #69

AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY OF  
AVON, IN STEARNS COUNTY, MINNESOTA.

WHEREAS, the City of Avon, in Stearns County, Minnesota is the owner of lands situate within the Township of Avon, in Stearns County, Minnesota, described as follows, to-wit:

All that part of Government Lot 3, Section 27, Township 125, Range 30, described as follows: Beginning at the Southeast corner of Government Lot 3; thence North along the East line of said Government Lot 3, 924 feet; thence West 230 feet; thence North 01°16' West 196.03 feet, to the point of beginning of the tract herein described; thence North 87°01' West 247.26 feet; thence South 76°31' West 301.96 feet; thence South 81°01' West 477.74 feet; thence North 01°28' West 444.74 feet to the Southerly Right of Way line of Highway No. 52; thence Northeasterly along the Southerly Right of Way line to the point of intersection of the Southerly Right of Way line and the East line of Government Lot 3; thence South along the East line of Government Lot 3, 271 feet; thence West 230 feet; thence South 01°16' East 283.97 feet, to the point of beginning, according to the United States Government Survey thereof. Subject to rights acquired for public highway.

WHEREAS, M.S.A. 414.03 Subdivision 2 authorizes the governing bodies of municipalities to annex land to said municipality if the same is owned by said municipality, and,

WHEREAS, said land is urban in character and it is in the best interest of said city that the same be within the corporate limits of said city,

NOW, THEREFORE, the City Council in and for the City of Avon does hereby declare and ordain:

That the corporate limits of the City of Avon, in Stearns County, Minnesota, be and they hereby are extended to include that certain real estate hereinbefore described, and the same is hereby annexed and included in the City of Avon as effectually as if it had originally been a part thereof.

This ordinance shall become effective from and after its passage and publication.

Adopted by the City Council this 7th day of July, 1975.
