ORDINANCE NO. 076-46

An ordinance amending the City Code concerning City boundaries and changes thereto:

THE CITY COUNCIL OF THE CITY OF FARMINGTON ORDAINS AS FOLLOWS:

Section I. Title I, Chapter 11, Section 2(A) of the City Code is hereby amended by adding the following:

13. Upon receipt of petition for annexation by Robert and Lorraine Adelman, fee owners and Dakota Electric Association, option holders, dated August 30, 1976, and upon receipt of approval and waiver from the Castle Rock Town Board dated October 12, 1976, under Minnesota Municipal Board Docket Number A-3010, the following described lands are hereby declared annexed to and become a part of the municipality of Farmington:

That part of the West Half of the Northwest Quarter (NW $\frac{1}{4}$) of Section 6, Township 113, Range 19, lying North of the railroad right-of-way through said tract, Dakota County, Minnesota.
