ORDINANCE NO. 187

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GLENWOOD TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain Petition dated August 25, 1977, requesting annexation of the territory hereinafter described was duly presented to the City Commission of the City of Glenwood on the 6th day of September, 1977;

AND WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is 2.3 acres of platted land, no part of which is included within the incorporated limits of a City or borough;

AND WHEREAS, the Petition was signed by all owners of the lands described therein;

AND WHEREAS, no objections to the annexation have been received from the Town Board of Glenwood Township, or from the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed;

AND WHEREAS, the land described in the Petition abuts upon the City limits of the City of Glenwood at the northerly boundary thereof; NOW, THEREFORE, THE CITY OF GLENWOOD DOES ORDAIN:

Section 1. The City Commission hereby determines that the annexation will be to the best interest of the City and of the territory affected; that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and that none of said territory is now included within the limits of any city or borough.

Section 2. The corporate limits of the City of Glenwood are hereby extended to include the platted land described as follows, and

the same is hereby annexed to and included within the City of Glenwood as effectually as if it had originally been a part thereof:

Outlot 3A, Thompson's Addition to the Village (now City) of Glenwood, according to the plat thereof on file and of record in the Office of the County Recorder within and for Pope County, Minnesota.

AND

The West 25 feet of vacated Pope Street, which street lay between the East line of Outlot 3A and the West line of Outlot 2A, Thompson's Addition to the Village (now City) of Glenwood, and which said tract is more particularly described as follows:

Commencing at the Southeast corner of Outlot 3A,
Thompson's Addition to the City of Glenwood;
Thence Easterly along an extension of the South line
of said Outlot 3A a distance of 25 feet;
Thence Northerly and parallel to the East line of said
Outlot 3 A to a point intersected by an extension Easterly
of the North line of said Outlot 3A;

Thence Westerly a distance of 25 feet to the Northeast corner of said Outlot 3A;

Thence Southerly along the East line of said Outlot 3A to the place of beginning.

Section 3. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Clerk of Glenwood Township, and the County Auditor.

Section 4. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 3 hereof.
