ORDINANCE NO. 36

Hackensack"

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HACKENSACK TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated August 17th, 1977, requesting annexation of the territory hereinafter described was duly presented to the council on the 6th day of September, 1977; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 58 acres of unplatted land, no part of which is included within the limits of an incorporated city, or borough; and WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the lead described in the petition abuts upon the city limits at the southerly boundary thereof;

The council of the City of Heckensack, Minnesota, ordains:

<u>Section 1.</u> The city council hereby determines (1) that the annexation will be to the best interest of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, or borough.

<u>Section 2.</u> <u>Territory Annexed.</u> The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof;

> That part of Government Lot Ten (10) lying South and West of Boy River of Section Twenth-nine(29), Township One Hundred Forty (140), Range Thirty(30).

## AND ALSO:

The Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$  NE $\frac{1}{4}$ ) of Section Thirty(30), Township One Hundred Forty (140), Range Thirty(30).

<u>Section 3.</u> <u>Filing.</u> The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Clerk, and the County Auditor.

Section L. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3. Adopted by the Council this 15th day of November, 1977.
