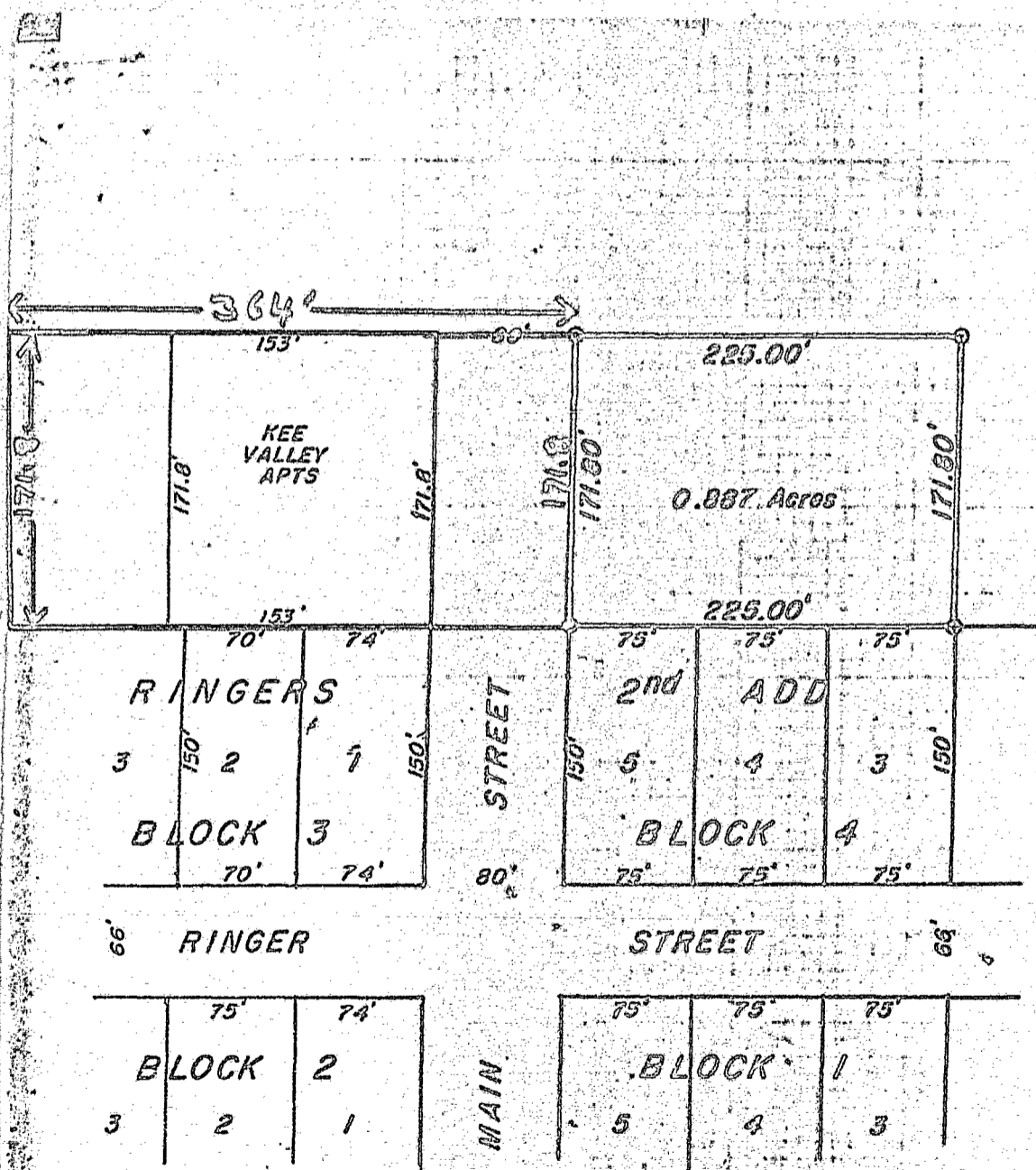

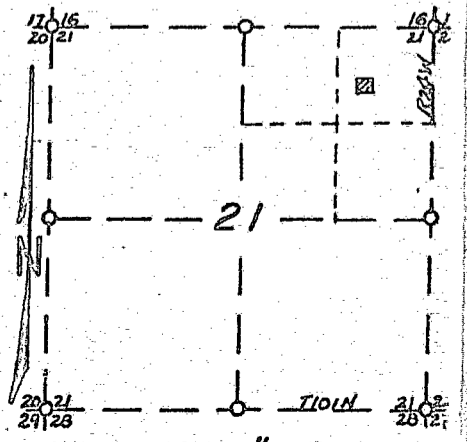

**Public notice**

**AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF KIESTER TO INCLUDE CERTAIN UNINCORPORATED AND UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.**

WHEREAS, a certain petition dated April 3, 1977, requesting annexation of the territory hereinafter described in Exhibit A was duly presented to the council on the 3rd day of April, 1977; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is one acre more or less of unplatted land, no part of which is included within the limits of an incorporated city; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the Northern boundary thereof; The City Council of the City of Kiester, Minnesota, ordains:

**Section 1.** The city council hereby determines (1) that the annexation will be to the best interest of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city.

**Section 2. Territory Annexed.** The corporate limits of the city are hereby extended to include the unplatted land described in Exhibit A, which is attached hereto and made a part hereof and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof.

**Section 3. Filing.** The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, and the Faribault County Auditor.

**Section 4. Effective Date.** This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.

**Exhibit A**

Beginning at the Northwest Corner of Ringer's Second Addition to the City of Kiester, Faribault County, Minnesota, as the same is platted and recorded in the office of The Register of Deeds of Faribault County, Minnesota; thence North 171.8 feet on a northerly extension of the West line of said Addition; thence East 364 feet on a line parallel with the North line of said Addition; thence South 171.8 feet to the Northwest corner of Block Four (4) in said Addition; thence West 364 feet on the North line of said Addition, to the point of beginning; being part of the North one-half of the Northeast Quarter of Section Twenty One (21), Township One Hundred One (101), Range Twenty Four (24) West, Faribault County, Minnesota, subject to public easement for street purposes on the East 80 feet thereof.
