

Ordinance No. 76-4

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LINDSTROM TO INCLUDE CERTAIN UNINCORPORATED PLATTED AND UNPLATTED LAND, NOT EXCEEDING 200 ACRES IN AREA, ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition, signed by all the owners of the tract herein described, dated March 29, 1976, requesting annexation of the territory hereinafter described was duly presented to the council on the 8th day of April, 1976; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 4.5 acres of land, no part of which is included within the limits of an incorporated city, or borough; and

WHEREAS, the petition was signed by all owners and

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the South boundary thereof;

The council of the City of Lindstrom, Minnesota, ordains:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the platted and unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally

been a part thereof:

That part of the East Half of the Northeast Quarter (E½ of NE¼) of Section Four (4), Township Thirty-three (33), Range Twenty (20), platted as Outlot A of the recorded plat of Town and Country Estates, Chisago County, Minnesota:


AND that part of Government Lot Five (5), Section Three (3), Township Thirty-three (33), Range Twenty (20), described as follows: Beginning at the northwest corner of said Section 3; thence North 89°49'03" East assumed bearing, along the north line of said Section 3 a distance of 391.35 feet to the intersection with the west line of the recorded plat of Sundberg's Beach 1st Addition; thence South 28°42'05" West 630.72 feet along the west line of said plat to the southwest corner thereof; thence North 50°32'46" West 66.01 feet along the northeasterly line of the recorded plat of Town and Country Estates to the northeast corner of the recorded plat of Town and Country Estates 2nd Plat, Chisago County, Minnesota; thence North 54°45'45" West 78.02 feet along the northerly line of said plat to the intersection with the west line of said Section 3; thence north 3°13'48" East 465.79 feet along said west line to the point of beginning.


Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.

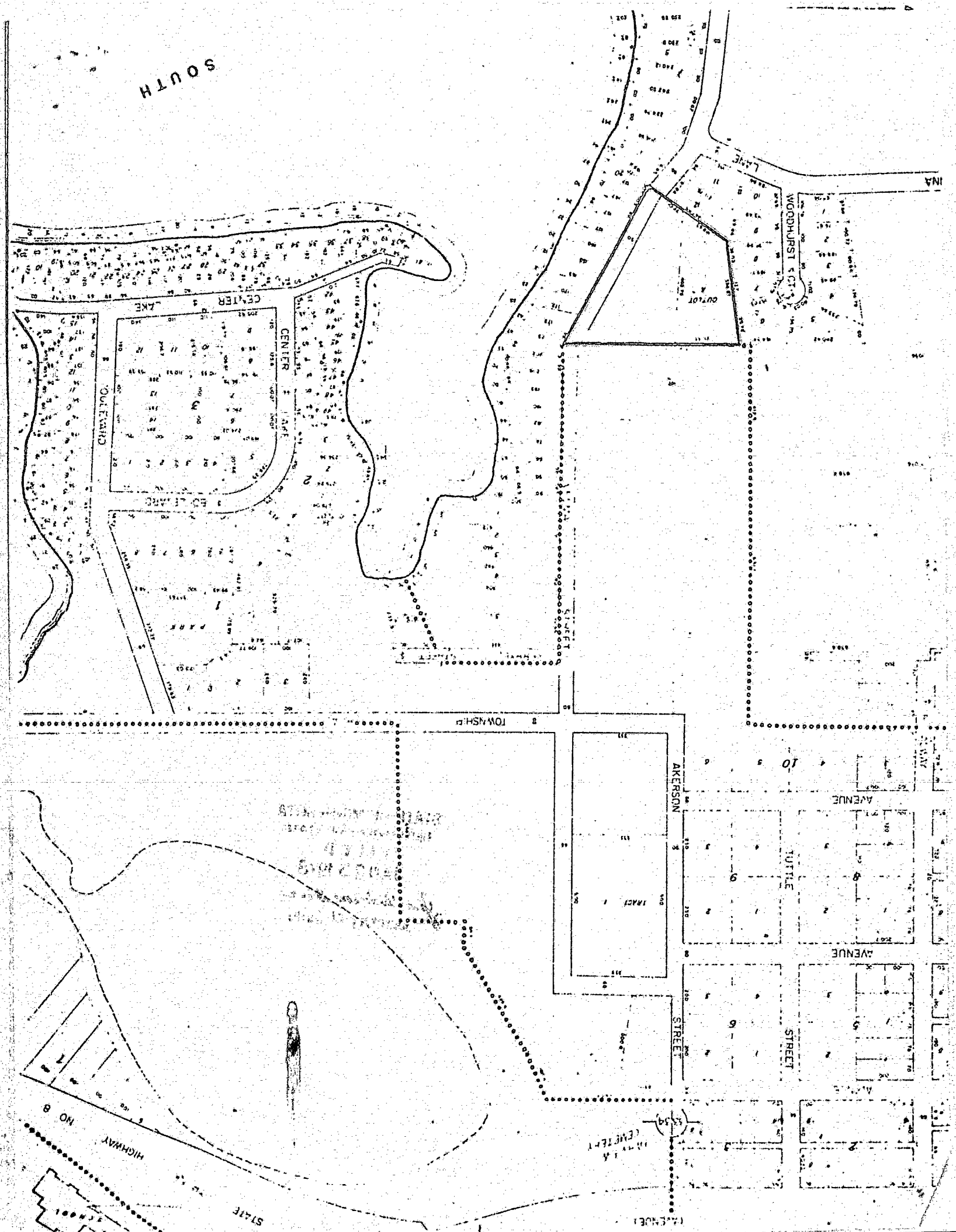
