Ordinance No. 77

AN ORDINANCE EXTENDIN: THE CORPORATE LIMITS OF THE CITY OF MADISON LAKE TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated Cctober 3, 1977, requesting annexation of the territory hereinafter described was duly presented to the council on the third day of October, 1977; and WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 2.64 acres of platted land, no part of which is included within the limits of an incorporated city, or borough; and WHEREAS, the petition was signed by all owners; and WHEREAS, a waiver of objection to the annexation has been received from the town board dated October 12,1977; and WHEREAS, the land described in the petition abuts upon the city limits at the western boundary thereof; The council of the City of Madison Lake, Minnesota, ordains:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally

been a part thereof:

That part of the SE2 of the NW2, Section 34, T109 N, Range 25W, lying South of the Railroad and East of Lot 3, Block 1, Hoehn's Subdivision, later to be described as Pine Knoll Subdivision.

Section 3. Filing. The city clerk (recorder) is hereby directed to file certified copies of this ordinance with the

Minnesota Municipal Commission, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
