ORDINANCE NO. A-77-124

AN ORDINANCE TO AMEND AN ORDINANCE KNOWN AS  
CHAPTER 13, UNCODED ORDINANCES IN EFFECT, OF  
THE CITY CODE OF THE CITY OF MANKATO, MINNESOTA.

The City of Mankato, Minnesota, hereby ordains:

WHEREAS, a petition was duly filed with the City Clerk requesting annexation of the Territory hereinafter described; and

WHEREAS, the petition was signed by Dorothy M. Finnegan, owner of said property; and

WHEREAS, said petition was examined by the Engineering Department of the City of Mankato and then duly considered by the Planning Commission; and

WHEREAS, the Town Board has waived the sixty-day waiting period and no objections have been received from the Town Board nor the County Board; and

WHEREAS, the quantity of land embraced within the area described in the petition, and bounded as described, is approximately .75 acres of unplatted land, no part of which is included within the limits of an incorporated municipality; and

WHEREAS, the land described herein abuts upon the City Limits at the northerly boundary thereof, and is or is about to become urban or suburban in character;

The City Council hereby determines that the annexation will be to the best interests of the City and of the territory affected; and hereby orders that the corporate limits of the City are hereby extended to include the land described as follows, and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:


The North 455 feet of the  $E\frac{1}{2}$   $NW\frac{1}{4}$   $NW\frac{1}{4}$   $SE\frac{1}{4}$  of Section 8, Twp. 108, Range 26, excepting therefrom the following circumscribed tracts:

Commencing at the Northwest corner of the said above described tract, thence running South on line a distance of 200 feet, thence East 150 feet, thence North 200 feet to the North line of said described tract, thence West on line 150 feet to the place of beginning.

The South 255 feet of the North 455 feet of the  $E\frac{1}{2}$   $NW\frac{1}{4}$   $NW\frac{1}{4}$   $SE\frac{1}{4}$  of said Section 8, Township 108, Range 26.


The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.


