EXTRACTS OF MINUTES OF MEETING OF THE CITY  
COUNCIL OF THE CITY OF MONTGOMERY, LESUEUR  
COUNTY, MINNESOTA HELD AUGUST 27, 1973

Pursuant to due call and public notice thereof a regular meeting of the City Council of the City of Montgomery, LeSueur County, Minnesota was held the 27th. day of August, 1973 at 6:30 P.M. for the purpose of acting on routine business of the City and to consider the annexation of a certain parcel of property to the City by ordinance.

The following members were present: Mayor Francis C. Wiskocil, aldermen Frank Halik, George Dvorak, Henry Peroutka, Frank Svejda and Recorder-Treasurer Edward J. Loula and the following were absent: none.

Alderman Peroutka introduced the following ordinance and moved its adoption.

ORDINANCE #139

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF  
THE CITY OF MONTGOMERY TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY THE CITY OF MONTGOMERY AND COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS OF SAID CITY AND ABUTTING THEREON.

THE COUNCIL OF THE CITY OF MONTGOMERY HEREBY ORDAINS:

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory abuts upon the corporate limits of the City of Montgomery which encompass it and the territory is deemed to be urban in character; and

WHEREAS, this territory is owned in fee by the City;

THEREFORE, The Common Council of the City of Montgomery ordains:

1. The corporate limits of the City of Montgomery, Minnesota are hereby extended to include the unplatted property described as follows:  
The East 391 feet of the North one-half of the Southwest Quarter of Section 3, Township 111 North, Range 23 West, in LeSueur County, Minnesota, excepting therefrom the two following described tracts, Viz: Tract One: The South 33 feet thereof. Tract Two starting at a point 100 feet East and 453 feet North of the NW corner of Lot 20, in Block 1, Columbia Heights Addition to the City of Montgomery, in LeSueur County, Minnesota, thence running East 60 feet, thence North 36 feet, thence West 60 feet, thence South 36 feet to the place of beginning for Public Street purposes, in LeSueur County, Minnesota.

2. The City Recorder is directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the LeSueur County Auditor, the Town Clerk of Montgomery Township, the Secretary of State of the State of Minnesota and the Register of Deeds, Le Sueur County.


The motion for adoption of the foregoing ordinance was seconded by Alderman Dvorak and on vote taken yes, Peroutka, Dvorak, Svejda, Halik and Mayor Wiskocil, no, none. The foregoing Ordinance #139 duly adopted this 27th. day of August 1973 goes into effect on publication.


