PETITION FOR ANNEXATION

To: City Council  
City of Mountain Lake, Minnesota.

The undersigned, being sole property-owner, and in lawful possession, of the following-described tract, to-wit:

A parcel of land lying in the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Thirty-four (34) in Township One Hundred Six (106) North, of Range Thirty-four (34), West of the Fifth Principal Meridian in Cottonwood County, Minnesota, described as follows:

Commencing at the Southwest corner of said Southwest Quarter (SW $\frac{1}{4}$ ), this being the place of beginning; thence running north on the West boundary line of said Southwest Quarter (SW $\frac{1}{4}$ ) Six Hundred Sixty Feet (660'); running thence east parallel with the South boundary line of said Southwest Quarter (SW $\frac{1}{4}$ ) a distance of One Thousand Four Hundred Fifty-two Feet (1,452'), running thence south parallel with the West boundary line of said Southwest Quarter (SW $\frac{1}{4}$ ) a distance of Six Hundred Sixty Feet (660') to a point in the South boundary line of said Southwest Quarter (SW $\frac{1}{4}$ ); running thence west along the South boundary line of said Southwest Quarter (SW $\frac{1}{4}$ ) a distance of One Thousand Four Hundred Fifty-two Feet (1,452') to the place of beginning; said parcel containing approximately twenty-two acres.

(Containing approximately 22 acres; including abutting roads and rights-of-way; and which tract abuts upon the City of Mountain Lake, Minnesota.)
