



ORDINANCE NO. 232

AN ORDINANCE DECLARING CERTAIN LAND TO BE ANNEXED
TO THE CITY OF ST. JAMES, MINNESOTA

BE IT ORDAINED by the City of St. James, Minnesota, as follows:

- (1) The following tracts of land lying adjacent to the City of St. James and in the County of Watonwan described as follows:

PARCEL 1

The South 33 1/2 feet of Lots One (1), Two (2), Three (3) and Four (4) in Block Two (2) of Schwingler's Subdivision of Lot Six (6) in Section 23, Township 106, Range 32 and a part of the Southeast Quarter of Section 14, Township 106, Range 32, South of the railroad right of way limits, Watonwan County, Minnesota.

Parcel 2

All of Block Three (3) except that part thereof lying West of the East line of said Lot Five (5) in Block Two (2) extended Southerly in a straight line across Block Three (3) of Schwingler's Subdivision of Lot Six (6) in Section 23, Township 106, Range 32 and a part of the Southeast Quarter of Section 14, Township 106, Range 32, Watonwan County, Minnesota,

and

All that part of the vacated alley located between Lots One (1), Two (2), Three (3) and Four (4) in Block Two (2) and all that part of Block Three (3) except that part thereof lying West of the East line of Lot Five (5) in Block Two (2) extended Southerly in a straight line across Block Three (3) of Schwingler's Subdivision of Lot Six (6) in Section 14, Township 106, Range 32 and a part of the Southeast Quarter of Section 14, Township 106, Range 32 South of the Railroad right of way limits, all in Watonwan County, Minnesota.

are hereby annexed and declared to be part of the City of St. James and to be included in the corporate limits thereof.

(2) This Ordinance shall take effect from and after date of passage and publication.
